## 5-Year History/Summary



- In Total, between 2017 and 2021, the Program(s) have provided over \$5.3 Million of State dollars towards acequia/community ditch infrastructure improvement projects.
  - Over 60 projects completed
  - Total Construction Costs in excess of \$12.4M boosting local/rural economy of New Mexico




- Acequia and Community Ditch systems

- Have valid water rights as per State Engineer Office
- Are in Compliance with EO 2013-006
  - Audit Office of the State Auditor
  - Budget Reporting NM Dept. of Finance and Admin.

## Acequia and Community Ditch Infrastructure Fund (ACDIF) - Overview

- 2019 Legislative Session Senate Bill 438 passed and was signed into law by Governor Michelle Lujan Grisham
  - Appropriates \$2.5M annually from the Irrigation Works Construction Fund (IWCF) to the ACDIF to be administered by the New Mexico Interstate Stream Commission (NMISC)
    - Increase of \$600K annually from \$1.9M previously requested by NMISC
    - for planning, engineering design, or construction of irrigation works of acequias or community ditches for the purposes of restoration, repair, improvement of irrigation efficiency or protection from floods
  - Requires that the NMISC shall:
    - In consultation with the New Mexico Acequia Commission (NMAC) and the New Mexico Acequia Association (NMAA), develop guidelines and criteria for program eligibility, applications and selection requirements;
    - Prioritize the provision of funding based on project readiness;
    - Review acequia and community ditch plans and specifications and inspect completed projects;
       and
    - Report biannually to the NMAC on the progress of projects funded through the fund and the expenditure of money from the fund.
  - Guidelines approved at May 26, 2021 NMSIC Meeting

### **ACDIF**

#### Planning

- Assist acequias and community ditches in the planning and scoping phase of their project.
- Assess and identify potential solutions to identified problem with conceptual design alternatives and high-level cost estimates.
- Contractual services of on-call engineering firms that NMISC has under contract or small PSA, if needed.

### **ACDIF**

- Engineering
  - Cover the cost of the engineering design services of selected projects (up to \$50,000 per acequia per year).
    - All engineering services required to provide final construction drawings (stamped by a NM licensed professional engineer), and engineer's construction cost estimate, and a bid package.
  - Application is required and projects will be ranked in accordance with the ACDIF Guidelines.

### **ACDIF**

#### Construction

- ACDIF funding will pay for the NMISC share of the total project construction costs of the following cost-share programs:
  - NMISC 90/10 Cost-Share Program
  - US Army Corps of Engineers Section 215 and 1113 Programs
  - NMACD Regional Conservation Partnership Program (RCPP)
- Written request required and projects funded on a first-come, firstserved basis.
- NMISC staff will work with each acequia or community ditch in determining which cost-share program best fits their needs.
- Acequias or community ditches may also request funding for the engineering services required for bidding assistance, construction oversight and inspection, and providing as-builts for the completed project.

## NMISC 90/10 Cost-Share Program

- Grant from the Interstate Stream Commission
  - 90% of Project Cost provided by the State of New Mexico
  - 10% Acequia Responsibility
    - May be paid by:
      - ISC Loan
      - Assessment of parciantes (acequia members)
      - Other Sources of Funding (i.e.: Grants, Donations, etc.)
  - Maximum project size \$250K per fiscal year

## COE 215/1113 Programs

- US Army Corps of Engineers ®
- Joint Federal/State Cooperative Program
  - Water Resource Development Act of 1986
  - NM Irrigation Works Construction Fund
- Cost-Share
  - 75% Federal
  - 20% State
  - 5% Acequia
- Maximum project size \$2M per fiscal year

## NMACD RCPP Program



- Joint Federal/State Partnership Program
  - NM Association of Conservation Districts
  - NM Interstate Stream Commission
- Cost-Share
  - 50% Federal
  - 45% State
  - 5% Acequia
- State's cost-share is capped at \$225K per fiscal year


## Federal Programs



- Fund Leveraging
  - Acequias CAN leverage ISC Loans and CIP Monies into these Programs
- Federal Laws/Regulations must be followed during these projects (i.e. environmental assessments, 404/401 permits, archeological clearances, etc.)

## ISC Loan Program

- Loan funds at 2.5% interest typically a 10-year repayment schedule
- Used for engineering design, construction & rehabilitation of any acequia project
- No Set Deadline applications accepted throughout the year



## Capital Outlay Projects

- NMISC is the state agency responsible for the administration of capital outlay funds to individual acequias/community ditches.
- Currently administering approximately 200 individual capital outlay appropriations for acequias/community ditches totaling approximately \$15.2M (2018-2021).
