# Thursday, July 14

# Welcome and Introductions (9:10 a.m.)

Dr. Margie Huerta, executive director, NHCC, welcomed committee members, staff and guests to the NHCC. She said that the NHCC is a part of the Cultural Affairs Department, and funding comes from the state. She said that the mission of the NHCC is to preserve, promote and advance Hispanic art, culture and humanities.

Committee members and staff introduced themselves.

# Veterans' Services Department (VSD) (9:25 a.m.)

Sonya L. Smith, secretary, VSD, gave an update on the community-based outpatient clinics (CBOCs). Since the last meeting in May, there has been a reversal in the proposed closures of the CBOCs. Diane Mourning Brown, director, Healthcare Division, VSD, said that the junior bill from the 2022 regular legislative session provided assistance in funding for organizations that help not only homelessness veterans, but also veterans who need assistance with obtaining COVID-19 vaccines. # New Mexico Veterans Integration Centers (VIC) (10:21 a.m.)

Brock Wolff, chief executive officer, New Mexico VIC, said that there are three essential services that the VIC offers: emergency housing, transitional housing and rapid rehousing. Thomas Tozier, mayor's liaison and coordinator, Veterans and Military Affairs, City of Albuquerque, described the background of the work done within the mayor's office with the implementation of a new division dedicated to military and veterans' affairs. Lindsey Kay, founder and chief executive officer, Paws and Stripes, said that the program is the second accredited organization in the state that provides service dogs. Paws and Stripes has been in New Mexico for 12 years and works with local shelters and the city to get dogs from rescues and shelters. Ms. Kay said that the mission of Paws and Stripes is to provide animal-based assisted therapy and other mental health services to veterans.
