(Speaker appoints Committee.)

FL. LEADER: "Mr. Speaker. I move the House postpone action indefinitely on all bills remaining on the Speaker's table, on the calendar or in committee, except the bills in the Enrolling and Engrossing Committee."

(NOTE: This motion may be made earlier in the proceedings.)

WHIP: "Second the motion."
