AN ACT

RELATING TO LIQUOR LICENSE FEES; CHANGING THE LICENSE FEE FOR
CLUBS LICENSED TO SELL ALCOHOLIC BEVERAGES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 60-6A-15 NMSA 1978 (being Laws 1981,
Chapter 39, Section 32, as amended) is amended to read:

"60-6A-15. LICENSE FEES.--Every application for the
issuance or renewal of the following licenses shall be
accompanied by a license fee in the following specified
amounts:

A. manufacturer's license as a distiller, except a
brandy manufacturer, three thousand dollars (\$3,000);

B. manufacturer's license as a brewer, three
thousand dollars (\$3,000);

C. manufacturer's license as a rectifier, one
thousand fifty dollars (\$1,050);

1 D. wholesaler's license to sell all alcoholic
2 beverages for resale only, two thousand five hundred dollars
