AN ACT

RELATING TO CIVIL FORFEITURE OF PROPERTY; ENACTING THE
FORFEITURE ACT; AMENDING, REPEALING AND ENACTING SECTIONS OF
THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. [NEW MATERIAL] SHORT TITLE. -- Sections 1
through 12 of this act may be cited as the "Forfeiture Act".

Section 2. [NEW MATERIAL] PURPOSE OF ACT. -- The purpose
of the Forfeiture Act is to make uniform the standards and
procedures for the seizure and forfeiture of property used or
intended to be used in the commission of a crime.

Section 3. [NEW MATERIAL] DEFINITIONS. -- As used in the
Forfeiture Act:

A. "conviction" means an alleged violator has
entered a plea of guilty or nolo contendere or been found

1 guilty in the trial court and has waived or exhausted all
2 rights to an appeal;

3 B. "crime" means an offense punishable by
4 imprisonment for one year or more, a violation of laws or
5 rules regarding hunting or fishing or a violation of laws
6 regarding gambling;

7 C. "law enforcement officer" means a state or
8 municipal police officer, county sheriff, deputy sheriff,
9 conservation officer, motor transportation enforcement officer
10 or other state employee authorized by state law to enforce
11 criminal statutes, but "law enforcement officer" does not
12 include correctional officers;

13 D. "owner" means a person who has a legal or
14 equitable ownership interest in property;

15 E. "property" means tangible or intangible
16 personal property or real property; and

17 F. "property subject to forfeiture" means property
18 described and declared to be subject to forfeiture by a state
19 law outside of the Forfeiture Act.

20 Section 4. [NEW MATERIAL] JURISDICTION AND VENUE OF
21 FORFEITURE PROCEEDINGS. -- A district court has jurisdiction of
22 forfeiture proceedings. Venue for:

23 A. the issuance of a pre-seizure order and
24 subsequent forfeiture proceedings pursuant to the order is in
25 the district court for the county where the property alleged

1 to be subject to forfeiture is located unless the property is
2 a business, in which case venue is in the district court for
3 the county where the principal office of the business is
4 located; and

5 B. forfeiture proceedings of property seized
6 without a prior court order is in the district court for the
7 county in which the property was seized.

8 Section 5. [NEW MATERIAL] SEIZURE OF PROPERTY. -- Property
9 subject to forfeiture may be seized by a law enforcement
10 agency:

11 A. pursuant to an order of seizure issued by a
12 district court having jurisdiction based on a sworn
13 application of a law enforcement officer from which a
14 determination is made by the court that:

15 (1) there is a substantial probability that
16 the state will prevail on the issue of forfeiture and that
17 failure to enter the order will result in the property being
18 destroyed, removed from the jurisdiction of the court or
19 otherwise made unavailable for forfeiture; and

20 (2) the need to preserve the availability of
21 the property through the entry of the requested order
22 outweighs the hardship to the alleged owner and other parties
23 known to be claiming interests in the property; and

24 B. if the property alleged to be subject to
25 forfeiture is not a residence or a business, it may be seized

1 by a law enforcement agency without a prior court order when:

2 (1) the seizure is incident to an arrest for
3 a crime, a search conducted pursuant to a search warrant or an
4 inspection conducted pursuant to an administrative inspection
5 warrant and the law enforcement officer making the arrest or
6 executing the search or inspection warrant has probable cause
7 to believe the property to be subject to forfeiture and that
8 the subject of the arrest, search warrant or administrative
9 inspection warrant is an owner of the property;

10 (2) the property seized has been the subject
11 of a prior judgment in favor of the state or a political
12 subdivision in a criminal injunction or forfeiture proceeding;
13 or

14 (3) the law enforcement officer making the
15 seizure has probable cause to believe the property is subject
16 to forfeiture and that the delay occasioned by the need to
17 obtain a court order would frustrate the seizure.

18 Section 6. [NEW MATERIAL] POST-SEIZURE REQUIREMENTS. --

19 Within thirty days after the seizure of property alleged to be
20 subject to forfeiture, the law enforcement agency making the
21 seizure shall:

22 A. if the property was seized without a prior
23 court order:

24 (1) immediately apply for a court order of
25 seizure;

1 (2) provide notice and an opportunity to be
2 heard on the application by persons known to claim ownership
3 or other interests in the property; and

4 (3) if the application for a seizure order is
5 denied, return the property immediately to the owner unless
6 possession of the property is illegal; and

7 B. if the property was seized pursuant to a court
8 order or if the court enters an order of seizure pursuant to
9 Subsection A of this section and the law enforcement agency
10 determines to go forward with forfeiture proceedings against
11 the property, it shall prosecute the crime in relation to
12 which the property is alleged to be subject to forfeiture and
13 the forfeiture proceedings in a bifurcated trial.

14 Section 7. [NEW MATERIAL] APPLICABLE RULES OF
15 PROCEDURE. --In a bifurcated trial pursuant to the Forfeiture
16 Act, the Rules of Criminal Procedure for the District Courts
17 shall apply in the criminal prosecution, and the Rules of
18 Civil Procedure for the District Courts shall apply to the
19 forfeiture.

20 Section 8. [NEW MATERIAL] BURDEN OF PROOF. --The state
21 shall prove the elements necessary to adjudicate a forfeiture
22 by clear and convincing evidence.

23 Section 9. [NEW MATERIAL] DETERMINATION OF OWNERSHIP--
24 COMPLAINT--SUMMONS--NOTICE OF HEARING--SERVICE OF PROCESS. --

25 A. Within thirty days of seizure, the state shall

1 file a complaint of forfeiture. The complaint shall include:

2 (1) a description of the property alleged to
3 be subject to forfeiture;

4 (2) the date and place of seizure of the
5 property;

6 (3) the name and address of the law
7 enforcement agency making the seizure; and

8 (4) the reason the property is alleged to be
9 subject to forfeiture.

10 B. Service of process shall be made in the manner
11 required by Rule 1-004 NMRA for the service of a summons in a
12 civil action and shall be served upon the person from whom the
13 property was seized, the owner and all persons known or
14 reasonably believed by the state to have an interest, whether
15 ownership or some other interest, in the property.

16 C. If the property alleged to be subject to
17 forfeiture is real property or a motor vehicle, the law
18 enforcement agency seizing the property shall have a title
19 search performed and shall include as persons to be served
20 pursuant to Subsection B of this section all persons shown to
21 have an ownership or security interest in the property.

22 Section 10. [NEW MATERIAL] COURT DETERMINATION. --

23 A. Claims to the property shall be filed by way of
24 answer to the complaint of forfeiture and shall be filed
25 within thirty days of the date of service of the complaint.

1 B. On the date set for hearing, the court shall
2 proceed to adjudicate all claims to the property alleged to be
3 subject to forfeiture. If no claims have been filed, the
4 court may enter a judgment of forfeiture by default.

5 C. If the court determines that the person charged
6 with the crime for which the property is alleged to be subject
7 to forfeiture is not the owner of the property, the forfeiture
8 proceeding shall be dismissed and the property shall be
9 delivered to the person determined to be the owner unless
10 possession of the property is illegal.

11 D. A party prevailing in its claim against the
12 state that the person charged with the crime for which the
13 property is alleged to be subject to forfeiture is not the
14 owner of the property shall be awarded costs and reasonable
15 attorney fees and shall not be subject to any charges by the
16 state for storage of the property or expenses incurred in the
17 preservation of the property. Costs and attorney fees shall
18 not be awarded to the state. The law enforcement agency
19 making the seizure of the property is liable for the costs and
20 attorney fees awarded.

21 E. If claims have been filed and, after hearing,
22 the court determines that the property is subject to
23 forfeiture, it shall enter a judgment of forfeiture if:

24 (1) the criminal prosecution of the owner
25 results in a conviction; and

1 (2) the value of the property forfeited does
2 not unreasonably exceed the pecuniary gain derived or sought
3 to be derived by the crime, the pecuniary loss caused or
4 sought to be caused by the crime or the value of the convicted
5 owner's interest in the property.

6 Section 11. [NEW MATERIAL] DISPOSITION OF FORFEITED
7 PROPERTY. -- Forfeited property, if it is not currency, shall be
8 sold at public sale by the law enforcement agency making the
9 seizure, or shall be otherwise disposed of according to law.
10 Forfeited currency and the proceeds of the sale of forfeited
11 property shall be distributed:

12 A. first, to pay reasonable expenses incurred for
13 storage and protection of the property;

14 B. second, the balance shall be paid as
15 restitution to or on behalf of victims, if any, of the crime
16 related to the forfeiture if the defendant is convicted of
17 that crime; and

18 C. third, the balance to the governing body of the
19 seizing agency to be used to enforce narcotics law violations,
20 drug treatment or prevention programs, or other substance
21 abuse initiatives, except for forfeitures of property subject
22 to forfeiture pursuant to Chapter 17 NMSA 1978, in which case
23 the balance shall be deposited in the game protection fund.

24 Section 12. [NEW MATERIAL] SAFEKEEPING OF SEIZED
25 PROPERTY PENDING DISPOSITION. --

1 A. Seized currency alleged to be subject to
2 forfeiture shall be deposited with the clerk of the district
3 court in an interest-bearing account.

4 B. Seized property other than currency or real
5 property, not required by federal or state law to be
6 destroyed, shall be:

- 7 (1) placed under seal; and
8 (2) removed to a place designated by the
9 district court; or
10 (3) held in the custody of the seizing law
11 enforcement agency.

12 C. Property shall be kept by the custodian in a
13 manner to protect it from theft or damage and, if ordered by
14 the district court, insured against those risks.

15 Section 13. Section 17-2-20.1 NMSA 1978 (being Laws
16 1979, Chapter 321, Section 1, as amended) is amended to read:

17 "17-2-20.1. SEIZURE AND FORFEITURE--PROPERTY SUBJECT.--

18 A. All firearms and bows and arrows may be subject
19 to seizure and forfeiture when used as instrumentalities in
20 the commission of the following crimes:

- 21 (1) illegal possession or transportation of
22 big game during closed season;
23 (2) taking big game during closed season;
24 (3) attempting to take big game by the use of
25 spotlight or artificial light; and

7 seizure and forfeiture when operated in violation of the
8 provisions of Section 17-2-31 NMSA 1978, regarding hunting by

10 ~~subsection, the motor vehicle shall be disposed of in~~
11 ~~accordance with the provisions of Section 17-2-20.2 NMSA 1978.]~~

12 ~~D. No conveyance is subject to forfeiture under~~

21 C. Seizure and forfeiture proceedings shall be
22 conducted pursuant to the provisions of the Forfeiture Act."

23 Section 14. Section 18-6-9.3 NMSA 1978 (being Laws 1993,
24 Chapter 176, Section 11) is amended to read:

25 "18-6-9.3. CULTURAL PROPERTY-- SEIZURE AND FORFEITURE OF

1 INSTRUMENTS. -- ~~[A.] Any instrument, vehicle, tool or equipment~~
 2 ~~used or intended to be used to violate the provisions of the~~
 3 ~~Cultural Properties Act is subject to seizure and forfeiture~~
