"9-19-4. DEPARTMENT ESTABLISHED. --There is created in the executive branch the "department of public safety". The department shall be a cabinet department and shall consist of, but not be limited to, five program divisions and one administrative division, as follows:

- A. the New Mexico state police division;
- B. the special investigations division;
- C. the training and recruiting division;
- D. the technical and emergency support division;
- E. the administrative services division; [~~and~~]
- F. the motor transportation division; and
- G. the fire protection division. "".
