**AN ACT**

**RELATING TO THE REDISTRICTING OF THE SENATE; ESTABLISHING  
SENATORIAL DISTRICTS; PROVIDING THE METHOD FOR ELECTING  
SENATORS; PROVIDING FOR THE FILLING OF VACANCIES; FIXING THE  
NUMBER, RESIDENCE AND TERMS OF SENATORS; REPEALING AND  
ENACTING SECTIONS OF THE NMSA 1978.**

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:**

**Section 1. SHORT TITLE.--This act may be cited as the  
"2001 Senate Redistricting Act".**

**Section 2. MEMBERSHIP.--The senate is composed of forty-  
two members to be elected from districts that are contiguous  
and that are as compact as is practical.**

**Section 3. RESIDENCE.--At the time of filing a  
declaration of candidacy for the office of state senator, the  
candidate shall reside in the district for which he files.**

1 Thereafter, if a senator permanently removes his residence  
2 from or maintains no residence in the district from which he  
3 was elected, he shall be deemed to have resigned and his  
4 successor shall be selected as provided in Section 4 of the  
5 2001 Senate Redistricting Act.

6 Section 4. ELECTIONS--VACANCIES.--

7 A. Members of the senate shall be elected for  
8 terms of four years.

9 B. If a vacancy occurs in the office of senator  
10 for any reason, the vacancy shall be filled as follows:

11 (1) for a senate district that is situated  
12 wholly within the exterior boundaries of a single county, the  
13 board of county commissioners of that county shall appoint the  
14 senator to fill the vacancy; and

15 (2) for a senate district situated within two  
16 or more counties:

17 (a) the board of county commissioners  
18 of each county in the senate district shall submit one name to  
19 the governor; and

20 (b) the governor shall appoint the  
21 senator to fill the vacancy from the list of names so  
22 submitted.

23 C. An appointment to fill a vacancy in the senate  
24 shall be for a term ending on December 31 after the next  
25 general election.

1           D. An appointment to fill a vacancy made before  
2 the general election of 2004 shall be made from the district  
3 as it was described in Laws 1991 (1st S.S.), Chapter 3,  
4 Sections 7 through 48. After the general election of 2004, a  
5 vacancy shall be filled by appointment from the district set  
6 out in the 2001 Senate Redistricting Act.

7           Section 5.   PRECINCTS. --

8           A. Precinct designations and boundaries used in  
9 the 2001 Senate Redistricting Act are those precinct  
10 designations and boundaries established pursuant to the  
11 Precinct Boundary Adjustment Act and revised and approved  
12 pursuant to that act by the secretary of state as of August  
13 31, 2001.

14           B. A board of county commissioners shall not  
15 create any precinct that lies in more than one senate district  
16 and shall not divide any precinct so that the divided parts of  
17 the precinct are situated in two or more senate districts.  
18 Votes cast in a statewide election from precincts created or  
19 divided in violation of this subsection are invalid and shall  
20 not be counted or canvassed.

21           Section 6.   DISTRICTS. --The districts of the senate shall  
22 be as set out in Sections 7 through 48 of the 2001 Senate  
23 Redistricting Act.

24           Section 7.   SENATE DISTRICT ONE. --Senate district one is  
25 composed of San Juan county precincts 20 through 29, 31, 40

20 Section 13. SENATE DISTRICT SEVEN. --Senate district  
21 seven is composed of Colfax county; Curry county precincts 1  
22 through 3, 10, 16 through 19, 34, 35 and 37; Harding county;  
23 Mora county precincts 1 through 4 and 6 through 11; Quay  
24 county; San Miguel county precinct 15; and Union county.

5 elected from the districts described in the 2001 Senate  
6 Redistricting Act at the 2004 and subsequent general  
7 elections.

8 Section 50. REPEAL. -- Sections 2-8C-1 through 2-8C-49  
9 NMSA 1978 (being Laws 1991 (1st S.S.), Chapter 3, Sections 1  
10 through 49, as amended) are repealed.
