AN ACT

**RELATING TO CONGRESSIONAL REDISTRICTING; ESTABLISHING
CONGRESSIONAL DISTRICTS FOR THE ELECTION OF REPRESENTATIVES TO
THE UNITED STATES CONGRESS; CHANGING A PROVISION OF THE
ELECTION CODE RELATING TO PRECINCTS; AMENDING, REPEALING AND
ENACTING SECTIONS OF THE NMSA 1978.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. Section 1-15-16 NMSA 1978 (being Laws 1991
(1st S.S.), Chapter 7, Section 1) is repealed and a new
Section 1-15-16 NMSA 1978 is enacted to read:**

**"1-15-16. [NEW MATERIAL] UNITED STATES REPRESENTATIVE--
COMPOSITION OF DISTRICTS. --**

**A. Congressional district one is composed of

15 "1-15-16.1. PRECINCTS. --

16 A. Precinct designations and boundaries used in
17 the [~~1991~~] 2001 congressional redistricting are those precinct
18 designations and boundaries established pursuant to the
19 Precinct Boundary Adjustment Act and revised and approved
20 pursuant to that act by the secretary of state as of [~~August~~
21 ~~16, 1991~~] August 31, 2001.

22 B. [~~The boards~~] A board of county commissioners
23 shall not create any precinct that lies in more than one
24 congressional district [~~nor~~] and shall [~~the boards of county~~
25 ~~commissioners~~] not divide any precinct so that the divided

2 congressional districts. Votes cast in [~~any general, primary~~
3 ~~or other~~] a statewide election from precincts created or
4 divided in violation of this subsection shall be invalid and
