12	SENATORIAL DISTRICTS; PROVIDING THE METHOD FOR ELECTING

14	NUMBER, RESIDENCE AND TERMS OF SENATORS; REPEALING AND

17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	Section 1. SHORT TITLEThis act may be cited as the
19	"2001 Senate Redistricting Act".
20	Section 2. MEMBERSHIPThe senate is composed of forty-
21	two members to be elected from districts that are contiguous
22	and that are as compact as is practical.
23	Section 3. RESIDENCEAt the time of filing a
24	declaration of candidacy for the office of state senator, the
25	candidate shall reside in the district for which he files.

1 Thereafter, if a senator permanently removes his residence from or maintains no residence in the district from which he 2 was elected, he shall be deemed to have resigned and his 3 successor shall be selected as provided in Section 4 of the 4 2001 Senate Redistricting Act. 5 Section 4. ELECTIONS--VACANCIES. --6 7 A. Members of the senate shall be elected for 8 terms of four years. 9 B. If a vacancy occurs in the office of senator 10 for any reason, the vacancy shall be filled as follows: 11 (1) for a senate district that is situated 12 wholly within the exterior boundaries of a single county, the 13 board of county commissioners of that county shall appoint the 14 senator to fill the vacancy; and for a senate district situated within two 15 (2)16 or more counties: the board of county commissioners 17 (a) 18 of each county in the senate district shall submit one name to 19 the governor; and 20 the governor shall appoint the **(b)** senator to fill the vacancy from the list of names so 21 submitted. 22 23 C. An appointment to fill a vacancy in the senate 24 shall be for a term ending on December 31 after the next 25 general election. . 139085. 2 - 2 -

D. An appointment to fill a vacancy made before the general election of 2004 shall be made from the district as it was described in Laws 1991 (1st S.S.), Chapter 3, Sections 7 through 48. After the general election of 2004, a vacancy shall be filled by appointment from the district set out in the 2001 Senate Redistricting Act.

Section 5. PRECINCTS. --

A. Precinct designations and boundaries used in the 2001 Senate Redistricting Act are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act and revised and approved pursuant to that act by the secretary of state as of August 31, 2001.

B. A board of county commissioners shall not
create any precinct that lies in more than one senate district
and shall not divide any precinct so that the divided parts of
the precinct are situated in two or more senate districts.
Votes cast in a statewide election from precincts created or
divided in violation of this subsection are invalid and shall
not be counted or canvassed.

Section 6. DISTRICTS.--The districts of the senate shall be as set out in Sections 7 through 48 of the 2001 Senate Redistricting Act.

Section 7. SENATE DISTRICT ONE.--Senate district one is composed of San Juan county precincts 13, 20 through 30, 40, .139085.2

Section 13. SENATE DISTRICT SEVEN. --Senate district seven is composed of Colfax county; Curry county precincts 1, 2, 10, 16 through 19, 23, 34, 35 and 37; Harding county; Mora . 139085.2 county precincts 1, 3 and 7 through 11; Quay county; San Miguel county precinct 15; Taos county precincts 3, 7 and 33; and Union county.

Section 14. SENATE DISTRICT EIGHT. --Senate district eight is composed of Bernalillo county precincts 551 and 552; Guadalupe county; San Miguel county precincts 1 through 14, 16 through 20 and 23 through 28; and Torrance county precincts 1 through 4 and 7 through 12.

Section 15. SENATE DISTRICT NINE. --Senate district nine is composed of Sandoval county precincts 11 through 13, 32 through 39, 46 through 48, 50, 53, 54, 58 through 64 and 67. Section 16. SENATE DISTRICT TEN. --Senate district ten is composed of Bernalillo county precincts 3, 4, 6 through 10, 13, 17, 18, 86, 89, 410, 418, 422 through 426, 485, 486, 489, 510 and 601.

Section 17. SENATE DISTRICT ELEVEN. -- Senate district eleven is composed of Bernalillo county precincts 32, 34, 41 through 45, 49, 50, 52, 53, 55, 63 through 67, 71, 72 and 135.
