SUMMARY

Synopsis of Bill

House Bill 232 appropriates \$100,000 from the general fund to New Mexico State University (NMSU) for the Cooperative Extension Service (CES) for expenditure in fiscal year 2003 (FY03) to produce and distribute a booklet entitled "Before You Check Out-Check Your Options" that would offer couples in conflict a range of options available to them prior to marriage dissolution. The available options shall include statewide private, public and faith-based programs and counseling services. Additionally, the booklet shall offer guidance regarding communication skills, conflict resolution, financial counseling, substance abuse issues, ending an affair, rebuilding or recommitting to a marriage, domestic violence resources and other topics that could benefit people whose marriages are in crisis.

Significant Issues

The CES analysis cites studies identifying New Mexico as one of the worst places in the nation to raise children. Reasons for this designation include the high rate of children from homes broken up by divorce. Improving communication between adults and between children and parents is considered crucial if the family is to survive as a unit. CES recommends the use of the booklet to help adults develop the skills necessary to maintain the family. Furthermore, states the CES analysis, a

stable family environment can serve as a protective buffer against school failure, school dropouts and involvement with drugs.

FISCAL IMPLICATIONS

The appropriation of \$100.0 contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of FY2003shall revert to the general fund.

House Bill 232 relates to House Bill 2, the General Appropriation Act, which contains the appropriation for NMSU.

OTHER SUBSTANTIVE ISSUES

The following is provided for information only. It is not intended as a commentary on the merits of the bill:

This request was not submitted to the NMSU Board of Regents and was not included in the regent's request to the CHE. Consequently, The CHE did not review nor did it recommend the program.
