



and/or increase property tax rates. The extent of the impacts would depend on the amount of property financed with the bonds. Although the IRB's would also make the use of the property exempt from the gross receipts and compensating tax, there is no new loss of State General Fund revenue because 501(c)(3) entities are already exempt from these taxes.
