15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	Section 1. Section 6-4-13 NMSA 1978 (being Laws 1999,
17	Chapter 208, Section 2) is amended to read:
18	"6-4-13. REQUI REMENTS.
19	A. Any tobacco product manufacturer selling
20	cigarettes to consumers within the state (whether directly or
21	through a distributor, retailer or similar intermediary or
22	intermediaries) after the date of enactment of this act shall
23	do one of the following:
24	(1) become a participating manufacturer (as
25	that term is defined in section II(jj) of the master settlement

3	(2) place into a qualified escrow fund by

8	(b) 2000: \$.0104712 per unit sold;

15	B. A tobacco product manufacturer that places funds

17	section shall receive the interest or other appreciation on
18	such funds as earned. Such funds themselves shall be released
19	from escrow only under the following circumstances:
20	(1) to pay a judgment or settlement on any
21	released claim brought against such tobacco product
22	manufacturer by the state or any releasing party located or
23	residing in the state. Funds shall be released from escrow

3 necessary to make payments required under such judgment or
4 settlement;

to the extent that a tobacco product 5 (2)manufacturer establishes that the amount it was required to 6 7 place into escrow on account of units sold in the state in a particular year was greater than [the state's allocable share 8 9 of the total payments that such manufacturer would have been 10 required to make in that year under the master settlement 11 agreement (as determined pursuant to section IX(i)(2) of the 12 master settlement agreement, and before any of the adjustments or offsets described in section IX(i)(3) of that agreement 13 other than the inflation adjustment)] the master settlement 14 agreement payments, as determined pursuant to section IX(i) of 15 that agreement, including after final determination of all 16 adjustments, that such manufacturer would have been required to 17 make an account of such units sold had it been a participating 18 manufacturer, the excess shall be released from escrow and 19 20 revert back to such tobacco product manufacturer; or

(3) to the extent not released from escrow under Paragraphs (1) or (2) of this subsection, funds shall be released from escrow and revert back to such tobacco product manufacturer twenty-five years after the date on which they were placed into escrow.

C. Each tobacco product manufacturer that elects to 2 place funds into escrow pursuant to Paragraph (2) of Subsection A of this section shall annually certify to the attorney 3 4 general that it is in compliance with Paragraph (2) of Subsection A of this section and Subsection B of this The attorney general may bring a civil action on 6 section. 7 behalf of the state against any tobacco product manufacturer that fails to place into escrow the funds required under 8 Paragraph (2) of Subsection A of this section and Subsection B 9 10 of this section. Any tobacco product manufacturer that fails in any year to place into escrow the funds required under 12 Paragraph (2) of Subsection A of this section and Subsection B of this section shall: 13

be required within fifteen days to place (1) such funds into escrow as shall bring it into compliance with Paragraph (2) of Subsection A of this section and Subsection B of this section. The court, upon a finding of a violation of Paragraph (2) of Subsection A of this section or Subsection B of this section, may impose a civil penalty to be paid to the state general fund in an amount not to exceed five percent of the amount improperly withheld from escrow per day of the violation and in a total amount not to exceed one hundred percent of the original amount improperly withheld from escrow;

in the case of a knowing violation, be (2)required within fifteen days to place such funds into escrow as . 149587. 1 4 -

shall bring it into compliance with Paragraph (2) of Subsection A of this section and Subsection B of this section. The court, upon a finding of a knowing violation of Paragraph (2) of Subsection A of this section or Subsection B of this section, may impose a civil penalty to be paid to the state general fund in an amount not to exceed fifteen percent of the amount improperly withheld from escrow per day of the violation and in a total amount not to exceed three hundred percent of the original amount improperly withheld from escrow; and

(3) in the case of a second knowing violation, be prohibited from selling cigarettes to consumers within the state (whether directly or through a distributor, retailer or similar intermediary) for a period not to exceed two years.

Each failure to make an annual deposit required under Paragraph (2) of Subsection A of this section shall constitute a separate violation."

Section 2. A new Section 6-4-13.1 NMSA 1978 is enacted to read:

"6-4-13.1. [<u>NEW MATERIAL</u>] SEVERABILITY.--If the 2004 amendment to Paragraph (2) of Subsection B of Section 6-4-13 NMSA 1978 is held by a court of competent jurisdiction to be unconstitutional, then Paragraph (2) of Subsection B of Section 6-4-13 NMSA 1978 shall be deemed to be repealed in its entirety. If Subsection B of Section 6-4-13 NMSA 1978 is thereafter held by a court of competent jurisdiction to be . 149587.1
