AN ACT
RELATI NG TO PUBLI C WDRKS; REQUI RI NG REG STRATI ON OF CERTAI N CONTRACTORS AND SUBCONTRACTORS; I MPOSI NG A FEE; CREATI NG A FUND; PROVI DI NG FOR REMEDI ES; MAKI NG AN APPROPRI ATI ON.

BE IT ENACTED BY THE LEG SLATURE OF THE STATE OF NEW MEXI CO:
Section 1. A new section of the Public Wbrks M nimunge Act is enacted to read:
" [ NEW MATERI AL] PUBLI C WDRKS CONTRACTS- - REG STRATI ON OF CONTRACTORS AND SUBCONTRACTORS. --
A. A contractor shall not bid on a contract for a public works project that is subject to the Public Wbrks $M$ ni mum Vage Act if the contractor is not registered with the I abor and industrial di vision of the labor department. A contractor shall not list a subcontractor in the bid proposal for a contract for a public works project subject to the Public . 148169. 4

Wbrks M ni mum Vage Act or use a subcontractor in performance of the contract unl ess the subcontractor is regi stered with the di vision. All tiers of subcontractors shall be regi stered for the purposes of $t$ his subsection.
B. The state or any political subdi vi si on of the state shall not accept a bid on a public works project subject to the Public Wbrks M ni mum Wage Act froma contractor that does not provide proof of registration with the di vision.
C. Contractors and subcontractors shall regi ster with the di vision on a formprovided by the di vi si on and in accordance with labor department rules. The di vi si on shall charge an annual regi stration fee of $t$ wo hundred dollars (\$200). The di vision shall issue to the appl icant a certificate of registration within fifteen days after recei ving fromthe appl icant the compl eted regi stration formand the regi stration fee.
D. Regi stration fees collected by the di vision shall be deposited in the labor enforcement fund.
E. For the purposes of this section, "contractor" and "subcontractor" incl ude any party acting in such capacity regardless of professi onal licensure, including publ ic entities."

Section 2. A new section of the Public Wbrks M nim Vage Act is enacted to read:
" [ NEW MATERI AL] LABOR ENFORCEMENT FUND - CREATI ON- USE. --

The "I abor enforcement fund" is created in the state treasury. The fund shall consi st of contractor and subcontractor registration fees collected by the I abor and industrial di vision of the I abor department and all investment and interest income fromthe fund. The fund shall be administered by the di vision and money in the fund is appropriated to the di vi si on for admini stration and enf or cement of the Public Wbrks M ni mum Vage Act. Mbney in the fund shall not revert to the general fund at the end of a fiscal year."

Section 3. A new section of the Public Wbrks $M$ ni mum Vage Act is enacted to read:
" [ NEW MATERI AL] REGI STRATI ON CANCELLATI ON, REVOCATI ON, SUSPENSI ON- - I NJ UNCTI VE RELI EF. - - The di rector of the I abor and industrial di vision of the labor department may:
A. cancel, revoke or suspend with conditions the regi stration of any party requi red to be regi stered pursuant to the Public Wbrks M ni mum Wage Act for failure to comply with the regi stration provisions or for good cause; and
B. seek injunctive relief in district court for failure to comply with the regi stration provisions of the Publ ic Wbrks M ni mum Wage Act."
