11	RELATING TO BEHAVIORAL HEALTH; PROVIDING A LOAN PROGRAM FOR
12	FUNDING CAPITAL PROJECTS FOR NONPROFIT BEHAVIORAL HEALTH
13	FACILITIES; ENACTING THE BEHAVIORAL HEALTH CAPITAL FUNDING ACT.

15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	Section 1. SHORT TITLEThis act may be cited as the
17	"Behavioral Health Capital Funding Act".
18	Section 2. PURPOSEThe purpose of the Behavioral Health
19	Capital Funding Act is to provide funding for capital projects
20	to eligible entities in order to increase behavioral health
21	care services to sick and indigent patients.
22	Section 3. DEFINITIONSAs used in the Behavioral Health
23	Capital Funding Act:
24	A. "authority" means the New Mexico finance

1 **B**. "capital project" means repair, renovation or 2 construction of a behavioral health facility; purchase of land; 3 or acquisition of capital equipment of a long-term nature; 4 **C**. "department" means the department of health; "eligible entity" means a nonprofit behavioral D. 5 health facility that has assets totaling less than ten million 6 7 dollars (\$10,000,000), is a 501(c)(3) nonprofit corporation for federal income tax purposes and serves primarily sick and 8 indigent patients; and 9 10 Е. "fund" means the behavioral health capital fund. Section 4. BEHAVIORAL HEALTH CAPITAL FUND. --11 12 A. The "behavioral health capital fund" is created as a revolving fund in the authority. The fund shall consist 13 of appropriations, loan repayments, gifts, grants, donations 14 and interest earned on investment of the fund. Money in the 15 fund shall not revert at the end of a fiscal year. 16 **B**. Money in the fund is appropriated to the 17 authority for the purpose of making loans to eligible entities 18 for capital projects pursuant to the Behavioral Health Capital 19 20 Funding Act. C. The fund shall be administered by the authority. 21 Administrative costs of the authority or department shall not 22 be paid from the fund. 23 Section 5. DEPARTMENT -- AUTHORITY -- RULES. -- The department, 24 in conjunction with the authority, shall adopt rules to 25 . 149227. 1

The authority is responsible for all financial 3 duties of the programs, including: 4 (1) administering the fund; 5 accounting for all money received, (2)6 7 controlled or disbursed for capital projects in accordance with the provisions of the Behavioral Health Capital Funding Act; 8 evaluating and approving loans, including 9 (3) 10 determining the financial capacity of an eligible entity; (4) enforcing contract provisions of loans, 11 12 including the ability to sue to recover money or property owed 13 the state: determining interest rates and other 14 (5) financial aspects of a loan and relevant terms of a contract 15 for services: and 16 (6) performing other duties in accordance with 17 the provisions of the Behavioral Health Capital Funding Act, 18 rules promulgated pursuant to that act or joint powers 19 20 agreements entered into with the department. D. The department is responsible for the following 21 duties: 22 (1) defining sick and medically indigent 23 persons for purposes of the Behavioral Health Capital Funding 24 Act; 25 . 149227. 1 - 5 -

15	as defined by the department; and
16	(2) by the authority that there is adequate
17	protection, including loan guarantees, real property liens,
18	title insurance, security interests in or pledges of accounts
19	and other assets, loan covenants and warranties or restrictions
20	or other encumbrances and pledges for the state funds extended
21	for the loan.
22	Section 7. ELIGIBLE ENTITYCHANGE IN STATUSIf an
23	eligible entity that has received a loan for a capital project
24	ceases to maintain its nonprofit status or ceases to deliver
25	behavioral health services at the site of the capital project
