AN ACT

RELATING TO CHILDREN; ENACTING THE CURFEW ENFORCEMENT ACT; PROVIDING MUNICIPALITIES AND COUNTIES WITH AUTHORITY TO ENACT CURFEW ORDINANCES; ENACTING NEW SECTIONS OF THE CHILDREN'S CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Children's Code is enacted to read:

"[NEW MATERIAL] SHORT TITLE.--This act may be cited as the "Curfew Enforcement Act"."

Section 2. A new section of the Children's Code is enacted to read:

"[NEW MATERIAL] DEFINITION. -- As used in the Curfew Enforcement Act, "neglected child" means a child:

A. who has been abandoned by the child's parent,

- B. who is without proper parental care and control or subsistence, education, medical or other care or control necessary for the child's well-being because of the faults or habits of the child's parent, guardian or custodian or the failure or refusal of the parent, guardian or custodian, when able to do so, to provide them;
- C. who has been physically or sexually abused, when the child's parent, guardian or custodian knew or should have known of the abuse and failed to take reasonable steps to protect the child from further harm; or
- D. whose parent, guardian or custodian is unable to discharge his responsibilities to and for the child because of incarceration, hospitalization or physical or mental disorder or incapacity."

Section 3. A new section of the Children's Code is enacted to read:

"[NEW MATERIAL] PURPOSE.--The purpose of the Curfew Enforcement Act is to:

- protect children from dangerous circumstances as a result of being without proper supervision during the hours between 12:00 a.m. and 5:00 a.m.; and
- B. provide for the general protection of children and the community."

"[NEW MATERIAL] AUTHORITY TO ENACT CURFEW ORDINANCES.--A

Upon a first violation, a law enforcement officer shall issue a citation to the child and the child shall be required to sign the citation. The citation shall include a notice that the child and the child's parents or legal guardians are required to attend a family education program no later than thirty days after issuance of the citation. Upon issuing the citation, the law enforcement officer shall simultaneously contact the department's call center and attempt to contact the child's parents or legal guardians.

- B. If the child and the child's parents or legal guardians fail to attend a family education program and the parents or legal guardians of the child received actual notice of the requirement to attend the family education program, the child shall be referred to the department. The department shall conduct an investigation to determine the best interests of the child pursuant to the provisions of the Abuse and Neglect Act.
- C. Upon a second violation of a curfew ordinance, the child shall be referred to the department. The department shall conduct an investigation to determine the best interests of the child pursuant to the provisions of the Abuse and Neglect Act.
- D. At the time of issuing a citation to a child, if a law enforcement officer has reasonable grounds to believe that the child is a neglected child, the law enforcement

officer shall take the child into custody and contact the department."

Section 7. A new section of the Children's Code is enacted to read:

"[NEW MATERIAL] DATA--RULES.--The department shall adopt rules regarding collection of data from municipalities and counties that enact a curfew ordinance. The department shall provide the legislature with an annual report regarding data collected from the municipalities and counties."

Section 8. DELAYED REPEAL. -- The provisions of the Curfew Enforcement Act are repealed effective July 1, 2007.

Section 9. EFFECTIVE DATE. -- The effective date of the provisions of this act is July 1, 2004.
