6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:	
7	Section 1. A new section of the Motor Vehicle Code is	
8	enacted to read:	
9	"NEIGHBORHOOD ELECTRIC CARS	
10	A. As used in this section, "neighborhood electric	
11	car" means a four-wheeled electric motor vehicle that:	
12	(1) has a maximum speed of more than twenty	
13	miles per hour but less than twenty-five miles per hour;	
14	(2) complies with the federal requirements	
15	specified in 49 CFR 571.500; and	
16	(3) is equipped with head lamps, stop lamps,	
17	front and rear turn signal lamps, tail lamps, reflex	
18	reflectors, a parking brake, at least one interior and one	
19	exterior rear view mirror, a windshield, windshield wipers, a	
20	speedometer, an odometer, braking for each wheel, seat belts	
21	and a vehicle identification number.	
22	B. Except as provided in Subsection C or D of this	
23	section, a neighborhood electric car, properly registered	
24	pursuant to the provisions of the Motor Vehicle Code, in	
25	compliance with the Mandatory Financial Responsibility Act	SB 226 Page 1

and driven by an individual with a valid driver's license, 1 2 may be operated on any street, roadway or highway under the 3 jurisdiction of either the state or a local authority if the posted maximum speed limit is thirty-five miles per hour or 4 5 less; provided, a neighborhood electric car may cross at an 6 intersection or permitted crossing point at any street, roadway or highway that has a posted maximum speed limit 7 8 higher than thirty-five miles per hour.

9 C. A local authority may prohibit the operation of
10 neighborhood electric cars on any road under its jurisdiction
11 if the governing body of the local authority determines that
12 the prohibition is necessary in the interest of safety.

D. The department of transportation may prohibit the operation of neighborhood electric cars on any road under its jurisdiction if it determines that the prohibition is necessary in the interest of safety.

E. Neighborhood electric cars are exempt from thefollowing provisions:

19 (1) the emblems or flashing lights
20 requirement for slow-moving vehicles in Section 66-3-887 NMSA
21 1978;

(2) any requirement for vehicle emission
inspections adopted by a local authority pursuant to
Subsection C of Section 74-2-4 NMSA 1978; and
