14	manufacturer's license. The fees shall not be more than fifty dollars (\$50.00) per	
15	license for a retail distributor's license, when the retail distributor has ten or more	
16	employees. The fees shall not be more than twenty-five dollars (\$25.00) per license	

for a retail distributor's license, when the retail distributor has fewer than tenemployees.

B. Every person who manufactures, possesses, transfers or
transports any drug precursor or who proposes to engage in the manufacture,
possession, transfer or transportation of any drug precursor shall obtain, annually, a
license issued by the board.
C. Persons licensed by the board to manufacture, possess, transfer

or transport drug precursors may manufacture, possess, transfer or transport those
 substances to the extent authorized by their license and in conformity with the other provisions of the Drug Precursor Act.

D. The following persons need not be licensed under the Drug
