15	Section 1. A new section of the Department of Health Act
16	is enacted to read:
17	"[<u>NEW MATERIAL</u>] COMPULSIVE GAMBLING COUNCILDUTIES
18	MEMBERSHIP
19	A. The "compulsive gambling council" is created.
20	The council is administratively attached to the department
21	pursuant to the Executive Reorganization Act. The council
22	consists of the following fifteen members, all of whom shall be
23	appointed by and serve at the pleasure of the governor:
