1 each year shall equal the previous year's rate plus the current 2 market basket index inflation adjustment as determined by the 3 federal centers for medicare and medicaid services. In years 4 when the reimbursement rate is re-based, the market basket 5 index shall be used to index each provider's operating costs to a common point of December 31 for the base year and then 6 7 indexed to a midpoint of the rate year to adjust for 8 inflation." 9 Section 2. APPROPRIATION .--10 Α. Three million two hundred thousand dollars 11 (\$3,200,000) is appropriated from the general fund to the human 12 services department for expenditure in fiscal year 2007 as 13 follows: 14 (1)two million two hundred thousand dollars 15 (\$2,200,000) to increase the medicaid reimbursement rate for 16 licensed nursing facilities and licensed intermediate care 17 facilities for the mentally retarded; and 18 one million dollars (\$1,000,000) to (2) 19 restore funding lost due to reductions in the medicaid 20 reimbursement rate made in fiscal years 2005 and 2006 to 21 licensed nursing homes and licensed intermediate care 22 facilities for the mentally retarded. 23 Any unexpended or unencumbered balance remaining Β. 24 at the end of fiscal year 2007 shall revert to the general 25 fund.
