15	Section 1. Section 22-2C-7 NMSA 1978 (being Laws 2003,

18	PLANSCORRECTIVE ACTION
19	A. A public school that fails to make adequate
20	yearly progress for two consecutive school years shall be
21	ranked as a school that needs improvement.
22	B. Within ninety days of being notified that a
23	public school within the school district has been ranked as a
24	public school that needs improvement, the school district shall
25	submit an improvement plan for that public school to the

	1	department. In developing the improvement plan, the local
	2	superintendent, the president of the local school board and the
	3	school principal of the public school that needs improvement
	4	shall hold a public meeting to inform parents and the public of

	6	suggestions from parents and the public on how to improve the
	7	public school. After the public meeting, the school district
	8	shall develop the public school's improvement plan, and the
	9	local school board shall approve the improvement plan before it
	10	is submitted to the department. The improvement plan shall be
	11	approved by the department within thirty days of its
	12	submission.
	13	C. The improvement plan shall include:
	14	(1) a record of the public meeting, including
	15	the date, an attendance roster and a list of the suggestions
	16	for improvement elicited from those in attendance;
	17	[(1)] <u>(2)</u> documentation of performance

	20	[(2)] <u>(3)</u> measurable objectives to indicate

The department shall evaluate 13 applications for assistance and may recommend changes to an application or to an improvement plan if warranted by the final The department shall consider innovative methods application. to assist the public school in meeting its improvement plan, including department or other school employees [to serve] 18 serving as a mobile assistance team to provide administrative, classroom, human resource and other assistance to the public school that needs improvement as needed and as provided in applications approved by the department.
