CAPITAL PROJECTS IN AZTEC

I request that the following be funded:

- to the department of environment

AZTEC WASTEWATER SYS IMPROVE

one million dollars (\$1,000,000) for improvements to the wastewater system in Aztec in San Juan county

AZTEC WASTEWATER TREATMENT PLANT IMPROVE

two million dollars (\$2,000,000) to plan, design, construct and equip improvements to the wastewater treatment plant in Aztec in San Juan county

AZTEC WATER DISTRIBUTION SYSTEM EXPANSION

one million four hundred thousand dollars (\$1,400,000) to plan, design, construct, equip and expand the water distribution system, including acquiring right-of-way property, in Aztec in San Juan county

- to the department of transportation

AZTEC MAIN STREET IMPROVEMENTS

six hundred seventy-five thousand dollars (\$675,000) to plan, design and construct improvements to Main street, including acquiring right-of-way property, in Aztec in San Juan county

- to the local government division of the department of finance and administration

AZTEC ANIMAL SHELTER IMPROVE AND EXPAND

five hundred thousand dollars (\$500,000) to plan, design, construct, equip and furnish the animal shelter expansion, including additional kennels, a hospital room and a staff area, in Aztec in San Juan county

### **AZTEC ANIMAS RIVER TRAIL CONSTRUCTION**

one hundred thousand dollars (\$100,000) to plan, design and construct the Animas River trail, including acquiring right-of-way property and upgrading existing trails, in Aztec in San Juan county

### **AZTEC HEALTH FCLTY RENOVATE**

five hundred thousand dollars (\$500,000) for renovations to the health facility in Aztec in San Juan county

### **AZTEC MVD BUILDING RENOVATE**

two hundred thousand dollars (\$200,000) to renovate, expand, furnish and equip the existing motor vehicle division building in Aztec in San Juan county

### **AZTEC SUBSTANCE ABUSE TREATMENT FCLTY CONSTRUCT**

five million dollars (\$5,000,000) to plan, design, construct, equip and furnish a substance abuse treatment facility in Aztec in San Juan county

### **SAN JUAN CO VEHICLE SERVICE FCLTY**

one million two hundred thousand dollars (\$1,200,000) to plan, design, construct and equip a county-owned vehicle-service facility in Aztec in San Juan county
