1 section is solely for the purpose of enhancing the financial 2 stability of title insurers for the benefit of insureds under 3 title insurance policies. The New Mexico Title Insurance Law 4 is not intended and should not be construed to create any duty 5 to search and examine that runs to the benefit of, or to create 6 any right or cause of action in favor of, any person other than 7 a title insurer.] The title insurer shall be solely liable 8 under the policy for errors and mistakes made by its agents and 9 its employees in the title search and examination required by 10 this section.

Β. Evidence of the examination of title and determination of insurability shall be preserved and retained in the files of the title insurer or its title insurance agent for a period of not less than fifteen years after the title insurance policy has been issued. Instead of retaining the original evidence, the title insurer or title insurance agent may in the regular course of business establish a system whereby all or part of the evidence is recorded, copied or reproduced by any process that accurately and legibly reproduces or forms a durable medium for reproducing the contents of the original. This subsection shall not apply to:

(1) a title insurer assuming liability through a contract of reinsurance; or

(2) a title insurer acting as coinsurer if one of the other coinsuring title insurers has complied with this .165292.1 - 2 -
