AN ACT

RELATING TO HIGHER EDUCATION; CHANGING PROVISIONS AND
DISTRIBUTIONS OF THE FACULTY ENDOWMENT FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 21-1-27.1 NMSA 1978 (being Laws 2002,
Chapter 31, Section 1, as amended by Laws 2003, Chapter 379,
Section 1 and by Laws 2003, Chapter 392, Section 1) is amended
to read:

"21-1-27.1. FACULTY ENDOWMENT FUND CREATED.--

A. The "faculty endowment fund" is created in the
state treasury. The fund shall consist of appropriations,
income from investment of the fund, gifts, grants, donations
and bequests. Money in the fund shall not revert at the end of
any fiscal year.

B. The faculty endowment fund shall be administered

13 ~~requests for additional disbursement are received by the~~

15 G. ~~The endowment funds of the institutions shall~~
16 ~~not be expended but shall be invested by the institutions in~~
17 ~~accordance with the prudent man rule, and in accordance with~~
18 ~~the provisions of Section 21-1-38 NMSA 1978. The income from~~
19 ~~the investments shall be used by the institutions to provide~~
20 ~~funding for chairs, professorships and faculty development~~
21 ~~programs, including paying all or a portion of the salary of~~

10 used to match private contributions to establish endowments
11 for chairs, professorships and faculty development programs
12 in the areas of interest identified by the governor, as
13 follows:

14 (1) the "governor's chair in (name of
15 discipline)";

16 (2) the "governor's professorship in (name
17 of discipline)"; and

18 (3) the governor's distinguished faculty
19 member in (name of discipline)".

20 D. Matching funds to the four-year public post-
21 secondary educational institutions for the endowments shall
22 be:

23 (1) five hundred thousand dollars (\$500,000)
24 to match private contributions of at least that amount for
25 each governor's chair;
