SENATE BILL 1044

2. On page 2, line 12, after "to", insert "urban Indians who are residents of New Mexico or to".
3. On page 2, line 14, after the subsection designation "E.", strike the opening quotation mark and insert in lieu thereof "'New Mexico".
4. On page 2, line 16, strike "tribal" and after "member", insert "of a federally recognized tribe or an Alaska native who lives in an off-reservation urban area and is a New Mexico resident", strike the remainder of the line and strike line 17 up to the period.
5. On page 3, line 18, after "department", insert "and work to expand appropriate Indian education for tribal students in preschool through grade twenty".
6. On page 4, line 6, strike "tribal".
7. On page 4, line 19, before "tribes", insert "New Mexico".
8. On page 4, line 22, after "by", insert "New Mexico".
9. On page 5, line 4, after "districts", insert ", public post-secondary schools".
10. On page 5, line 5, before "tribes", insert "New Mexico".
11. On page 5, line 18, after "each", insert "New Mexico", after "or", insert "its" and strike "tribal".
12. On page 5, line 25, after "each", insert "New Mexico" and

after "or", insert "its" and strike "tribal".

13. On page 6, line 5, after "the", insert "New Mexico" and strike the second "tribal" and insert in lieu thereof "their".

15. On page 7, line 16, strike "seventeen" and insert in lieu thereof "sixteen".

16. On page 7, line 25, strike "four" and insert in lieu thereof "three".

17. On page 8, line 10, after "from", insert "New Mexico" and after "tribes", insert "and organizations involved in the education of tribal students".

18. On page 8, line 12, after "representatives", strike the remainder of the line and strike line 13 through "representatives".

19. On page 8, line 22, after "all", insert "New Mexico".

20. On page 9, line 15, before "tribes", insert "New Mexico".

21. On page 9, line 19, after "all", insert "New Mexico".
