I request that the following be funded:

- to the department of environment

BLANCO MDWC/MSWA WATER SYSTEM IMPROVE

three hundred thousand dollars (\$300,000) to plan, design and construct infrastructure for the water system for the Blanco mutual domestic water consumers and mutual sewage works association in San Juan county

FLORA VISTA WWATER SYSTEM CONSTRUCT

one million five hundred twenty-five thousand dollars (\$1,525,000) to plan, design and construct a wastewater system in Flora Vista in San Juan county

NORTH STAR DWC/MSW CO-OP WATER SYSTEM IMPROVE

four hundred thousand dollars (\$400,000) to plan, design and construct improvements to the water distribution system for the North Star domestic water consumers and mutual sewer works cooperative in San Juan county

AZTEC RESERVOIR #3 CONSTRUCT

one million dollars (\$1,000,000) to plan, design, construct and equip reservoir number 3, including acquiring rights of way and property, in Aztec in San Juan county

AZTEC WATER TANK/TRANSMISSION LINES CONSTRUCT

five hundred thousand dollars (\$500,000) to plan, design, construct and equip a water tank and transmission lines for the northern Aztec water system, including acquiring rights of way and property, in Aztec in San Juan county

BLOOMFIELD WATER LINES/FIRE HYDRANTS-NORTH 1ST ST

three hundred thousand dollars (\$300,000) to plan, design, construct, purchase and install water lines and fire hydrants along north First street in Bloomfield in San Juan county

six hundred sixty-seven thousand dollars (\$667,000) to plan, design, construct, renovate, equip and furnish a substance abuse treatment facility in San Juan county

AZTEC ANIMAS RIVER REC FACILITIES/TRAILS/BRIDGES

five hundred thousand dollars (\$500,000) to plan, design, construct and equip Animas river recreation facilities, trails and bridges, including acquiring rights of way and property, in Aztec in San Juan county

BLOOMFIELD EARLY CHILDHOOD CTR PLAYGROUND EQUIP

eighty thousand dollars (\$80,000) to plan, design, construct, purchase and install playground equipment at the Bloomfield early childhood center in Bloomfield in San Juan county

BLOOMFIELD FIRE & POLICE DEPTS RADIO/COMM EQUIP

three hundred thirty-five thousand dollars (\$335,000) to purchase and install microwave radio and communications equipment for the fire and police departments in Bloomfield in San Juan county

BLOOMFIELD FIRE/POLICE/MUNICIPAL COURT FCLTY

five hundred thousand dollars (\$500,000) to plan, design and construct improvements to the fire station, police and municipal court facility in Bloomfield in San Juan county

BLOOMFIELD KEFFALOS BALL PARK LIGHTING INSTALL

three hundred thousand dollars (\$300,000) to purchase and install equipment and field lighting at the Keffalos ball park in Bloomfield in San Juan county

SAN JUAN CO DOMESTIC VIOLENCE SHELTER CONSTRUCT

two million dollars (\$2,000,000) to plan, design, construct and equip a domestic violence shelter and counseling center in San Juan county

SAN JUAN REGIONAL ANIMAL SHELTER

seventy-five thousand dollars (\$75,000) for phase 1 of the San Juan regional animal shelter project, including a feasibility study, plan and design of the facility, acquisition of property, construction, equipment and furnishings, in Farmington in San Juan county

four hundred forty thousand dollars (\$440,000) to replace the roof at Blanco elementary school in the Bloomfield school district in San Juan county

BLOOMFIELD HIGH SCHL AUDITORIUM ROOF REPLACE

ninety-six thousand dollars (\$96,000) to replace the roof for the auditorium at Bloomfield high school in the Bloomfield school district in San Juan county

MESA ALTA JR HIGH SCHL ROOF REPLACE

six hundred eighty thousand dollars (\$680,000) to replace the roof at Mesa Alta junior high school in the Bloomfield school district in San Juan county

NAABA ANI ELEM SCHL MAIN BOILER REPLACE

two hundred thousand dollars (\$200,000) to replace the main boiler at Naaba Ani elementary school in the Bloomfield school district in San Juan county

RIO VISTA MID SCHL ROOF REPLACE

three hundred eighty thousand dollars (\$380,000) to replace the roof at Rio Vista middle school in the Bloomfield school district in San Juan county
