AN ACT

MAKING GENERAL APPROPRIATIONS AND AUTHORIZING EXPENDITURES BY
STATE AGENCIES REQUIRED BY LAW.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. FISCAL YEAR 2009 APPROPRIATIONS.--The
following amounts are appropriated from the general fund or
other funds as indicated for the purposes specified. Unless
otherwise indicated, the appropriations may be expended in
fiscal year 2009. Unless otherwise indicated, any unexpended
or unencumbered balance of the appropriations remaining at the
end of fiscal year 2009 shall revert to the appropriate fund:

A. fifty thousand dollars (\$50,000) is appropriated
from the general fund to legislative building services of the
legislative council service for increased utility and fuel
costs;

1 B. one million dollars (\$1,000,000) is appropriated
2 from the general fund to the administrative office of the
3 courts for drug courts statewide;

4 C. one hundred fifty thousand dollars (\$150,000) is
5 appropriated from the general fund to the aging and long-term
6 services department for one full-time-equivalent position and
7 associated costs for prescription drug assistance outreach;

8 D. four hundred thousand dollars (\$400,000) is
9 appropriated from the general fund to the human services
10 department for contracting with a statewide food bank program
11 to gather, pack, transport, distribute and prepare unsaleable
12 and surplus fresh produce to feed hungry and homeless New
13 Mexicans;

14 E. seven hundred thousand dollars (\$700,000) is
15 appropriated from the general fund to the workforce solutions
16 department for at-risk youth programs;

17 F. six hundred thousand dollars (\$600,000) is
18 appropriated from the general fund to the department of health
19 for emergency medical services for expenditure in fiscal year
20 2009 and subsequent fiscal years;

21 G. seven hundred thousand dollars (\$700,000) is
22 appropriated from the general fund to the department of health
23 for operations of the New Mexico behavioral health institute at
24 Las Vegas, Fort Bayard medical center and southern New Mexico
25 rehabilitation center;

1 H. seven hundred fifty thousand dollars (\$750,000)
2 is appropriated from the general fund to the children, youth
3 and families department for services and programs for victims
4 of domestic violence and their families;

5 I. nine hundred fifty thousand dollars (\$950,000)
6 is appropriated from the general fund to the board of regents
7 of the university of New Mexico for the college of nursing
8 expansion; and

9 J. four million three hundred thousand dollars
10 (\$4,300,000) is appropriated from the general fund to the state
11 equalization guarantee distribution for kindergarten plus
12 programs.

13 Section 2. SPECIAL APPROPRIATIONS.--The following amounts
14 are appropriated from the general fund or other funds as
15 indicated for the purposes specified. Unless otherwise
16 indicated, the appropriations may be expended in fiscal years
17 2008 and 2009. Unless otherwise indicated, any unexpended or
18 unencumbered balance of the appropriations remaining at the end
19 of fiscal year 2009 shall revert to the appropriate fund:

20 A. fifty thousand dollars (\$50,000) is appropriated
21 from the general fund to the legislative council service for
22 expenses associated with redistricting in the next federal
23 decennial;

24 B. two million dollars (\$2,000,000) is appropriated
25 from the general fund to the tourism department for general and

1 cooperative advertising costs and Native American tourism;

2 C. two million dollars (\$2,000,000) is appropriated
3 from the general fund to the cultural affairs department for
4 the state library for grants to public libraries throughout the
5 state, to conserve New Mexico depression-era public art, for a
6 statewide library database for public schools, for development
7 of cross-cultural educational documentaries and electronic
8 field trips in north central and northwestern New Mexico and
9 for relocating the items in the repository collections of the
10 museum of Indian arts and culture and the palace of the
11 governors;

12 D. one million five hundred thousand dollars
13 (\$1,500,000) is appropriated from the general fund to the
14 office of the state engineer for regional water planning; and

15 E. ten million dollars (\$10,000,000) is
16 appropriated from the general fund to the water and wastewater
17 project grant fund for administration by the New Mexico finance
18 authority.

19 Section 3. SUPPLEMENTAL APPROPRIATIONS.--The following
20 amounts are appropriated from the general fund, or other funds
21 as indicated, for expenditure in fiscal year 2008 for the
22 purposes specified. Disbursement of these amounts shall be
23 subject to the following conditions: certification by the
24 agency to the department of finance and administration and the
25 legislative finance committee that no other funds are available

1 in fiscal year 2008 for the purpose specified; and approval by
2 the department of finance and administration. Any unexpended
3 or unencumbered balances remaining at the end of fiscal year
4 2008 shall revert to the appropriate fund:

5 A. nine hundred fifty-one thousand two hundred
6 dollars (\$951,200) is appropriated from the general fund to
7 the board of regents of the university of New Mexico for
8 utility costs;

9 B. five hundred one thousand two hundred dollars
10 (\$501,200) is appropriated from the general fund to the board
11 of regents of New Mexico state university for utility costs;

12 C. one hundred two thousand nine hundred dollars
13 (\$102,900) is appropriated from the general fund to the board
14 of regents of New Mexico highlands university for utility
15 costs;

16 D. fifty-five thousand six hundred dollars
17 (\$55,600) is appropriated from the general fund to the board of
18 regents of western New Mexico university for utility costs;

19 E. one hundred twenty-one thousand five hundred
20 dollars (\$121,500) is appropriated from the general fund to the
21 board of regents of eastern New Mexico university for utility
22 costs;

23 F. one hundred fifty-nine thousand nine hundred
24 dollars (\$159,900) is appropriated from the general fund to the
25 board of regents of New Mexico institute of mining and

1 technology for utility costs;

2 G. thirty-six thousand five hundred dollars
3 (\$36,500) is appropriated from the general fund to the board of
4 regents of northern New Mexico state school for utility costs;
5 and

6 H. four million five hundred seventy-one thousand
7 dollars (\$4,571,000) is appropriated from the general fund to
8 the state equalization guarantee distribution for utility and
9 fuel costs.
