## **SUMMARY**

## **Synopsis of HTRC Amendment**

The House Taxation and Revenue Committee amendment to House Bill 484 amends the bill's effective date to be July 1, 2009 rather than January 1, 2009. This amendment erases the bill's fiscal impact in FY09.

## Synopsis of Original Bill

House Bill 484 would allow a lower gaming excise tax rate to be imposed on a racetrack casino with net win less than \$14 million in the preceding calendar year. The only racetrack casino expected to qualify for this preferential tax rate is Ruidoso Downs.

The effective date of the provisions of the original bill is January 1, 2009.

#### FISCAL IMPLICATIONS

Net win for Ruidoso Downs is expected to be \$8.6 million in FY10. Taxed at the current rate of 26 percent, Ruidoso Downs is currently expected to pay \$2.2 million in gaming excise tax in FY10.



Because casino's net win is not expected to exceed \$14 million in the near future, the casino's entire net win would be taxed at 10 percent once the provisions of House Bill 484 become effective in July 2009. The bill will reduce general fund revenue by \$1,381 thousand in FY10 and the fiscal impact will grow by 4.4 percent per year.

#### **SIGNIFICANT ISSUES**

As shown in the figure below, net win, the amount of revenue taken in less payouts, has fallen at Ruidoso Downs in recent years. Net win is most likely suffering at Ruidoso Downs due to increased competition. Zia Park in Hobbs opened around the beginning of 2005, and tribal casinos in the area also draw large crowds. In addition, some gaming establishments have found a loophole around the prohibition of gaming in Texas, leading to a small number of gaming establishments in El Paso drawing business away from nearby casinos in New Mexico.
