### **SUMMARY**

# Synopsis of Bill

House Bill 439 appropriates \$75.0 from the general fund to the New Mexico State Fair Commission for the purpose of an on-line technology-based mathematics and science program for educators at the African American Performing Arts Center.

# FISCAL IMPLICATIONS

The appropriation of \$75.0 contained in this bill is a non-recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of FY10 shall revert to the general fund.

According to the December 2008 revenue estimate, FY10 recurring revenue will only support a base expenditure level that is \$293 million, or 2.6 percent, less than the FY09 appropriation. All appropriations outside of the general appropriation act will be viewed in this declining revenue context.

The only general fund money received by SFC is for operations and programs at the African American Performing Arts Center. To effectively ensure informational technology (IT) properly operates, State Fair IT personnel may be involved in ensuring web based program is operational. PED points out, sufficient broadband and technology stations would be needed to support an online, technology-based mathematics and science program. The IT position responsible for overseeing the technology component is funded through revenues generated by SFC and not general fund dollars as SFC is an enterprise revenue agency.

#### SIGNIFICANT ISSUES

The on-line technology-based mathematics and science program will be for educators.

### **OTHER SUBSTANTIVE ISSUES**

According to PED, the state currently appropriates funds to the Innovative Digital Education and Learning (IDEAL-NM) initiative. One of the IDEAL-NM mission components is to provide online courses to educators. This could be viewed as a duplication of service.

## **ALTERNATIVES**

A viable alternative would be to work with IDEAL-NM to provide the desired supplemental online technology-based mathematics and science program for educators at the African American Performing Arts Center.
