SUMMARY

Synopsis of Bill

Senate Bill 123 add administrators to the Teacher Education Accountability Reporting System (TEARS) that measures and tracks teacher candidates from pre-entry to post-graduation in order to benchmark the productivity and accountability of New Mexico's educator workforce and re-names it the Educator Accountability Report (EAR).

FISCAL IMPLICATIONS

No significant fiscal implications.

SIGNIFICANT ISSUES

The Office of Educational Accountability reports that nationally, research indicates that school leadership is second only to teaching among school related factors that affect student learning. In addition, there is no recorded instance of a low-performing school making significant improvements without strong leadership. New Mexico faces the triple jeopardy of having a high-number of low-performing schools; a high percentage of principal turn over, and shortage of qualified individuals entering educational leadership programs and applying for principal positions.

TECHNICAL ISSUES

SB 123 requires an annual report with at least eight indicators of program success. Five of the eight indicators require matching PED data with the HED database. New Mexico is currently developing an integrated P-20 data system; however, until it is completed PED and HED would need to define a way to match secondary and postsecondary data. As of yet, STARS has not been designed or modified to carry this information and there appears to be some territorial issues to be resolved in order to move forward with the program. The STARS data warehouse at PED is designated as the repository of this data, yet the Higher Education Department continues to push for the development of its own system. This appears to be a duplication of effort and should probably not be considered as a reason for the delay in implementing the program.
