SUMMARY

Synopsis of Bill

Senate Bill 322 requires the Public Regulation Commission (PRC) to examine the rates and charges of a public utility with more than 10,000 customers no less frequently than every five years. If the utility has not filed a rate change request during the five-year period being considered, the PRC will be required to initiate the examination by first ordering the utility to provide notice of the examination to interested parties. Following the notice, the commission examination may proceed.

The bill adds a provision imposing the burden of proof on the utility to show that its current rates and charges are just and reasonable in a PRC-initiated rate examination.

FISCAL IMPLICATIONS

The PRC acknowledges that there would be some increase in PRC workload, although most electric utilities probably already are on a more regular schedule for rate filings than experienced in prior periods. According to the electric utilities, more frequent rate filings are anticipated because of the need to build additional electric generation and transmission facilities.

PERFORMANCE IMPLICATIONS

More frequent rate examinations may length the number of days to dispose of a rate case.

Periodic review of current rates could result in additional workload for the agency.
