#### ADMINISTRATIVE IMPLICATIONS

SJM 45 requests the Legislative Council form a task force for the 2009 interim to study the need for improved regulation of commercial wind facilities in New Mexico; and further requests that that at least six public members be appointed to the task force and that they represent communities and interests that have been affected by the sitting of commercial wind facilities in the state.

#### OTHER SUBSTANTIVE ISSUES

Reasons for SJM 45 cited in the bill are the following:

- utility-scale wind-powered electric generation facilities are almost completely unregulated; and the total environmental impact and ultimate viability of proposed utility-scale wind facilities should be taken into consideration to determine if they are truly responsible renewables; and
- the sitting of the current or planned industrial- scale wind facilities does not fall under public regulation commission review; and the protection of public health through safety standards, including setback standards from homes and noise limit standards that include hazardous low-frequency noise, should be considered; and
- protection of the environment, including scenery, historic sites and wildlife corridors, as well as night skies, should be taken into account; and
- a code of ethics for the wind power industry that guarantees procedural transparency to residents and provides for oversight of the industry is necessary;

# WHAT WILL BE THE CONSEQUENCES OF NOT ENACTING THIS BILL

A study may not be conducted.
