### SUMMARY

#### Synopsis of Bill

House Bill 16 reduces general fund appropriations contained in Laws 2009, Chapter 1 (Feed Bill), Sections 3 through 9, for permanent legislative offices by 5.3 percent. Although each legislative agency has a separate appropriation, the legislative council service is given authority to apply the reduction where needed to effectuate government efficiency.

The bill will be effective upon passage and signing due to the emergency clause.

### FISCAL IMPLICATIONS

House Bill 16 reduces FY10 general fund appropriations to the permanent legislative offices by \$839.4 thousand, excluding Legislative Building Services, which is included in Section 4 of the 2009 General Appropriation Act.

The Department of Finance and Administration will be required to reduce the appropriations and adjust agency allotment distributions accordingly.

## CONFLICTS

This bill contains a reduction rate of 5.3 percent for legislative agencies, whereas House Bill 17, which reduces the majority of other state agencies, has a reduction rate of 4.0 percent. Senate Bill 17 contains a 6.8 percent reduction for legislative agencies.
