3. On page 20, lines 23 and 24, strike "one million seven hundred fifty thousand dollars ( $\$ 1,750,000$ )" and insert in lieu thereof "two million dollars ( $\$ 2,000,000$ )".
4. On page 21, lines 2 and 3, strike "one million seven hundred fifty thousand dollars ( $\$ 1,750,000$ )" and insert in lieu thereof "two million dollars ( $\$ 2,000,000$ )".
5. On page 21, line 7, after "acquisitions", insert ", bus acquisitions".
6. On page 21, line 11 , strike "and".
7. On page 21 , line 12, strike "three million dollars ( $\$ 3,000,000$ )" and insert in lieu thereof "two million dollars $(\$ 2,000,000)$ ".
8. On page 21 , between lines 13 and 14 , insert the following new paragraphs:
"(3) five hundred thousand dollars $(\$ 500,000)$ to purchase school buses statewide; and
(4) five hundred thousand dollars $(\$ 500,000)$ for student count equipment in school buses statewide;

11. On page 22, line 14 , strike "fifteen million dollars $(\$ 15,000,000) "$ and insert in lieu thereof "sixteen million dollars $(\$ 16,000,000) "$.
12. On page 22, lines 21 through 23, strike Subparagraph (c) in its entirety.
13. Reletter the succeeding subparagraphs accordingly.
14. On page 24, line 6, strike "seventeen million dollars $(\$ 17,000,000) "$ and insert in lieu thereof "eighteen million dollars $(\$ 18,000,000)$.
15. On page 26 , line 3 , strike "ten million dollars $(\$ 10,000,000) "$ and insert in lieu thereof "twelve million dollars $(\$ 12,000,000)$ ".
16. On page 27, line 18 , strike "two million dollars $(\$ 2,000,000) "$ and insert in lieu thereof "two million five hundred thousand dollars $(\$ 2,500,000)$ ".
