BE IT FURTHER RESOLVED that the legislative finance committee, in making its recommendations, be requested to consider the goals of protecting people and communities through law enforcement, judicial and corrections programs; providing for an educated citizenry by ensuring that all children receive an equal opportunity to achieve academic success; encouraging job creation and entrepreneurship by removing regulatory barriers to job production; providing a safety net of social services; building and maintaining the infrastructure to accommodate transportation and utilities; requiring state agencies to conduct business in an efficient, transparent and accountable manner; and managing public property and natural resources while protecting the property rights of private property owners; and

BE IT FURTHER RESOLVED that the legislative finance committee make its recommendations to the first session of the fiftieth legislature regarding development of measurable outcomes for each of the recommended core functions of .182350.1
