AN ACT

RELATING TO CRIMINAL LAW; PROVIDING NO TIME LIMITATION FOR PROSECUTING THE CRIMES OF MURDER IN THE SECOND DEGREE, VOLUNTARY MANSLAUGHTER, INVOLUNTARY MANSLAUGHTER, ASSISTING SUICIDE AND HOMICIDE BY VEHICLE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 30-1-8 NMSA 1978 (being Laws 1963, Chapter 303, Section 1-8, as amended) is amended to read:

"30-1-8. TIME LIMITATIONS FOR COMMENCING PROSECUTION. -- A person shall not be prosecuted, tried or punished in any court of this state unless the indictment is found or information or complaint is filed within the time as provided:

- for a second degree felony, within six years Α. from the time the crime was committed;
- for a third or fourth degree felony, within five .188128.1
