SUMMARY

Synopsis of Bill

Senate Bill 176 would expand the purpose of the corrections department intensive supervision fund, allowing New Mexico Corrections Department (NMCD) to use money placed in the fund for a wider of variety of NMCD prison and probation/parole-related purposes.

Under current law, the probation and parole supervision fees collected by NMCD and placed in the fund can only be used by NMCD to fund or pay for intensive supervision programs or essentially the supervision of offenders on intensive supervision. However, the majority of offenders placed on probation or parole are not placed on intensive supervision or into intensive supervision programs. By allowing the supervision fees collected and placed in the fund to now be used to help pay the costs associated with the supervision of the majority of the probationers and parolees, and to help pay for or fund the costs incident to the confinement of inmates including NMCD's notification duties under the Victims of Crime Act, NMCD will have the administrative discretion and flexibility to best utilize the fund's monies based on current need.

FISCAL IMPLICATIONS

None to NMCD or the State. If anything, the administrative flexibility created by this bill will

enable NMCD to save or at least better utilize the fund's money as needed.

SIGNIFICANT ISSUES

By allowing the supervision fees collected and placed in the fund to be used to help pay the costs associated with the supervision of the majority of the probationers and parolees, and to help pay for or fund the costs incident to the confinement of inmates including NMCD's notification duties under the Victims of Crime Act, NMCD will have the administrative discretion and flexibility to best utilize the fund's monies based on current need. This bill would allow NMCD to operate more efficiently.
