SUMMARY

Synopsis of Bill

WORK FORCE SKILLS DEVELOPMENT PROGRAM appropriates \$235,400 from the general fund to the Local Government Division of the Department of Finance and Administration to contract with the mid-region council of governments for a work force skills development program.

FISCAL IMPLICATIONS

The appropriation of \$235,400 contained in this bill is a nonrecurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of fiscal year 2013 shall revert to the general fund.

SIGNIFICANT ISSUES

The Mid-Region Council of Governments is the administrative staff and fiscal agent to the Central Workforce Development Board, which administers employment and training programs funded by the Workforce Investment Act (WIA). Additional general fund appropriated will expand existing services in the counties of Bernalillo, Torrance, Sandoval and Valencia.

Expenditures of federal pass-through funds by New Mexico's four local workforce development boards (Northern Board Central Board, Southwestern Board, and Eastern Board) under the Workforce Investment Act have increased in past years. The Central Board expended approximately 37 percent of total expenditures for fiscal years 2010 through 2012. The chart below contains federal WIA expenditures by the four boards for the past three fiscal years.
