11	SECTION 1. Section 66-5-35 NMSA 1978 (being Laws 1978,	
12	Chapter 35, Section 257, as amended) is amended to read:	
13	"66-5-35. LIMITED DRIVING PRIVILEGE UPON SUSPENSION OR	
14	REVOCATION	
15	A. Upon suspension or revocation of a person's	
16	driving privilege or driver's license following conviction or	
17	adjudication as a delinquent under any law, ordinance or rule	
18	relating to motor vehicles, the person may apply to the	
19	department for a driver's license, provisional license or	
20	instruction permit to drive, limited to use allowing the	
21	person to engage in gainful employment, to attend school or	
22	to attend a court-ordered treatment program, except that the	
23	person shall not be eligible to apply:	
24	(1) for a limited commercial driver's	
25	license or an ignition interlock license in lieu of a revoked	SB 442 Page l

(2) for a limited license when the person's

driver's license was revoked pursuant to the provisions of the Implied Consent Act, except as provided in the Ignition Interlock Licensing Act;

for a limited license when the person's (3) driver's license was revoked pursuant to the provisions of Section 66-8-102 NMSA 1978, except as provided in the Ignition Interlock Licensing Act;

(4) for a limited license when the person's driver's license is denied pursuant to the provisions of Subsection D of Section 66-5-5 NMSA 1978, except as provided in the Ignition Interlock Licensing Act; or

(5) for a limited license when the person's driver's license was revoked pursuant to a conviction for committing homicide by vehicle, great bodily harm by vehicle, or homicide by vehicle or great bodily harm by vehicle while under the influence of intoxicating liquor or drugs, as provided in Section 66-8-101 NMSA 1978, except as provided in the Ignition Interlock Licensing Act.

Upon receipt of a fully completed application that complies with statutes and rules for a limited license or an ignition interlock license and payment of the fee specified in this subsection, the department shall issue a limited license, ignition interlock license or permit to the SB 442

1 applicant showing the limitations specified in the approved 2 application. For each limited license, ignition interlock 3 license or permit to drive, the applicant shall pay to the department a fee of forty-five dollars (\$45.00), which shall 4 5 be transferred to the department of transportation. All 6 money collected under this subsection shall be used for DWI prevention and education programs for elementary and 7 secondary school students. The department of transportation 8 shall coordinate with the department of health to ensure that 9 10 there is no program duplication. The limited license or 11 permit to drive may be suspended as provided in Section 66-5-30 NMSA 1978." 12

"ignition interlock license" means a driver's license issued to a person by the division that allows that person to operate a motor vehicle with an ignition interlock device after that person's driving privilege or driver's license has been revoked or denied. The division shall clearly mark an ignition interlock license to distinguish it from other driver's licenses; and

9 D. "revoked" means the division, pursuant to the 10 provisions of Section 66-5-29 or 66-8-111 NMSA 1978, has 11 terminated a person's driving privilege or driver's license 12 for:

13 (1) driving while under the influence of 14 intoxicating liquor or drugs; or

15 (2) a conviction of homicide by vehicle or 16 great bodily harm by vehicle while under the influence of 17 intoxicating liquor or drugs."

A. A person whose driving privilege or driver's
license has been revoked or denied or who has not met the
ignition interlock license requirement as a condition of
reinstatement pursuant to Section 66-5-33.1 NMSA 1978 may
apply for an ignition interlock license from the division.
