19	<u>NMSA 1978</u> may be cited as the "Homeowner Association Act"."
20	SECTION 2. A new section of the Homeowner Association Act
21	is enacted to read:
22	"[<u>NEW MATERIAL</u>] FLAGSAn association shall not adopt or
23	enforce a restriction related to the flying or displaying of
24	flags that is more restrictive than the applicable federal or
25	state law or county or municipal ordinance."

1	SECTION 3. Section 47-16-15 NMSA 1978 (being Laws 2013,
2	Chapter 122, Section 15) is amended to read:
3	"47-16-15. APPLICABILITY
4	A. Except as provided in Subsections B and C of
5	this section, the Homeowner Association Act shall apply to all
6	homeowner associations created and existing within this state.
7	B. Sections [9, 10 and 14 of the Homeowner
8	Association Act] 47-16-9, 47-16-10 and 47-16-14 NMSA 1978 do
9	not apply to homeowner associations created before July 1,
10	2013; provided that any amendment to the community documents of
11	an association created before July 1, 2013 shall comply with
12	the Homeowner Association Act.
13	C. Except as provided in Sections [4 and 8 of the
14	Homeowner Association Act, that] 47-16-4 and 47-16-8 NMSA 1978
15	and Section 2 of this 2015 act, the Homeowner Association Act
16	does not invalidate existing provisions of the articles of
17	incorporation, declaration, bylaws or rules of a homeowner
18	association created before July 1, 2013.
19	D. The Homeowner Association Act does not apply to
20	a condominium governed by the Condominium Act."
21	SECTION 4. EFFECTIVE DATEThe effective date of the
22	provisions of this act is July 1, 2015.
