one hundred two thousand dollars (\$102,000) to construct electric utility line connections for the Mariano Lake chapter of the Navajo Nation in McKinley county

ZUNI PUEBLO COMMERCIAL AREA WWATER INFRASTRUCTURE

one million two hundred fifty-six thousand five hundred dollars (\$1,256,500) to plan, design and construct wastewater infrastructure for the Zuni commercial development area at the Pueblo of Zuni in McKinley county

one million four hundred three thousand four hundred fifty-four dollars (\$1,403,454) to construct a teen and youth center facility at the Pueblo of Zuni in McKinley county

five hundred thousand dollars (\$500,000) to plan, design, construct, renovate, furnish and equip a lifelong learning and technology center in Grants in Cibola county
