### SUMMARY

House Memorial 52 requests the continuance of the task force formed to study the delivery of services to sexually exploited minors and the effects of a safe harbor law on the delivery of paid services, and report its finds.

### FISCAL IMPLICATIONS

The Children, Youth and Families Department (CYFD) reports that there are no significant fiscal implications identified at this time.

### SIGNIFICANT ISSUES

Currently, CYFD has a representative on this task force, and continued participation can be absorbed by existing resources.

The Institute of Medicine (IOM) of the National Academies, studies crimes of commercial sexual exploitation and trafficking of children and adolescents. The IOM reports offer recommendations concerning strategies for responding to commercial sexual exploitation and sex trafficking of minors in the United States, new legislative approaches, and a research agenda. The report concludes that efforts to prevent, identify, and respond to commercial sexual exploitation and sex trafficking of minors in the United States require better collaborative approaches. These efforts need to confront demand and the individuals who commit and benefit

from these crimes. The recommendations in the report have the potential to advance and strengthen the nation's emerging efforts to prevent, identify, and respond to commercial sexual exploitation and sex trafficking of minors.
