SUMMARY

Synopsis of Bill

House Resolution 4 proposes to change house rules to prohibit persons from carrying firearms into the house chamber, galleries, lounge, hallways, or committee rooms.

FISCAL IMPLICATIONS

Depending on how the proposed change would be enforced there may be costs associated with installing metal detectors or adding members to the roundhouse security team.

SIGNIFICANT ISSUES

DPS stated that if checkpoints are required to enforce this law full time security personnel may be required to man the checkpoints. An additional consideration should be that, with massive amounts of people showing up when particular issues are being heard, considerable waits at any security checkpoints would become the norm. In the absence of security checkpoints, the law would be mostly unenforceable, except with respect to the few individuals who would seek to enter the capitol building while carrying their firearm out in the open. If a person is carrying a concealed firearm (whether they have a permit or not) and his/her concealment is effective, no

one would be able to tell that the person is carrying a firearm and is in violation of this resolution.

According to the National Conference of State Legislatures Alaska, Arizona, Idaho, Rhode Island, and New Mexico are the only states without prohibitions on firearms in state houses. Many states prohibit carrying weapons into meetings where any governing body is present including into state houses. For example, the prohibition for concealed carry license holders in Texas looks like this:

A license holder commits an offense if the license holder intentionally, knowingly, or recklessly carries a handgun under the authority of Subchapter H, Chapter 411, Government Code, regardless of whether the handgun is concealed, at any meeting of a governmental entity.
