AN ACT

RELATING TO HEALTH COVERAGE; ENACTING SECTIONS OF THE GROUP BENEFITS ACT, THE PUBLIC ASSISTANCE ACT, THE NEW MEXICO INSURANCE CODE, THE HEALTH MAINTENANCE ORGANIZATION LAW AND THE NONPROFIT HEALTH CARE PLAN LAW TO ESTABLISH REIMBURSEMENT PARITY BETWEEN PHARMACISTS AND CERTAIN OTHER LICENSED HEALTH PROFESSIONALS FOR THE SAME PHARMACEUTICAL CLINICAL SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new section of the Group Benefits Act is enacted to read:

"[NEW MATERIAL] PHARMACIST SERVICES--REIMBURSEMENT PARITY.--A group health plan shall not discriminate with respect to reimbursement under the group health plan against any pharmacist who is acting within the scope of that pharmacist's license. The group health plan shall reimburse

1 any pharmacist who provides a service at the same rate that the
2 group health plan reimburses, for the same service under that
3 group health plan, any physician or physician assistant

6 nurse practitioner licensed pursuant to the Nursing Practice
7 Act."

8 SECTION 2. A new section of the Public Assistance Act is
9 enacted to read:

10 "[NEW MATERIAL] PHARMACIST SERVICES--REIMBURSEMENT
11 PARITY.--The department shall ensure that any medical
12 assistance program or contractor providing services to the
13 medical assistance program does not discriminate with respect
14 to reimbursement under the medical assistance program against
15 any pharmacist who is acting within the scope of that
16 pharmacist's license. The medical assistance program or its
17 contractor shall reimburse any pharmacist who provides a
18 service at the same rate that the medical assistance program
19 reimburses, for the same service under that program, any
20 physician or physician assistant licensed pursuant to the
21 Medical Practice Act or the Osteopathic Medicine Act or any
22 advanced practice certified nurse practitioner licensed
23 pursuant to the Nursing Practice Act."

25 pharmacist's license. The insurer shall reimburse any

14 reimbursement pursuant to an individual or group health
15 maintenance organization contract that is delivered, issued for
16 delivery or renewed in this state against any pharmacist who is
17 acting within the scope of that pharmacist's license. The
18 carrier shall reimburse any pharmacist who provides a service
19 pursuant to an individual or group contract at the same rate
20 that the carrier reimburses, for the same service under that
21 individual or group contract, any physician or physician
22 assistant licensed pursuant to the Medical Practice Act or the
23 Osteopathic Medicine Act or any advanced practice certified
24 nurse practitioner licensed pursuant to the Nursing Practice
25 Act."

2 Plan Law is enacted to read:

3 "[NEW MATERIAL] PHARMACIST SERVICES--REIMBURSEMENT

4 PARITY.--A health care plan shall not discriminate with respect
5 to reimbursement pursuant to a subscriber contract that is
6 delivered, issued for delivery or renewed in this state against
7 any pharmacist who is acting within the scope of that
8 pharmacist's license. The health care plan shall reimburse any
9 pharmacist who provides a service pursuant to a subscriber at
10 the same rate that the carrier reimburses, for the same service
11 under that subscriber contract, any physician or physician
12 assistant licensed pursuant to the Medical Practice Act or the
13 Osteopathic Medicine Act or any advanced practice certified
14 nurse practitioner licensed pursuant to the Nursing Practice
15 Act."
