The House Floor #1 amendment inserts the word "reasonable" to clarify that "No such reasonable regulation shall be deemed in violation of freedom of speech rights in the Constitution of the United States or its Amendments."

Synopsis of Original Bill

SIGNIFICANT ISSUES

The proposed Fix It America Constitutional Amendment provides that Congress and state Legislatures regulate the role of money in elections and governance to ensure transparency, prevent corruption, and protect against the buying of access to or influence over representatives. Such regulations are not to be deemed in violation of freedom of speech rights. The Amendment also provides that legislative districts or districting plans shall not intentionally or unduly favor or disfavor any political party.

OTHER SUBSTANTIVE ISSUES

The Fix It America Constitutional Amendment shall be submitted to the United States Congress with a request that it be passed by the required two-thirds' vote and submitted to the states for ratification.
