12	information and educational materials to the public regarding
13	bone marrow donation through the national marrow donor program
14	and regarding organ donations. The department shall seek
15	assistance from the national marrow donor program to establish
16	a system to distribute materials, ensure that the materials are
17	updated periodically, fully disclose the risks involved in
18	donating bone marrow and address the education and recruitment
19	of minority populations.
20	B. The information and educational materials shall
21	include information on:
22	(1) the need for bone marrow donations;
23	(2) patient populations that would benefit
24	from bone marrow donations;
25	(3) how to join the bone marrow registry; and
