22	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
23	SECTION 1. A new section of Chapter 28 NMSA 1978 is

2 SECTION 2. A new section of Chapter 28 NMSA 1978 is 3 enacted to read:

"[NEW MATERIAL] DEFINITIONS.--As used in the Pregnant Worker Accommodation Act:

"employer" means a person or entity, including a Α. partnership, association, corporation, business trust, 8 unassociated group or agency employing four or more employees, or a person or entity acting on behalf of or as an agent of an 10 employer;

"reasonable accommodation" means a modification Β. or adaptation of the work environment, work rules or job responsibilities for as long as necessary upon an employee's request to enable the employee with a need arising from pregnancy or childbirth or a related condition to perform the job that does not impose an undue hardship on the employee's employer; and

С. "undue hardship" means an employment accommodation requiring significant difficulty or expense when considered in light of the following factors:

> (1) the nature and cost of the accommodation;

> > the number of persons the employer

the financial resources of the employer (2) involved in the provision of the reasonable accommodation;

A new section of Chapter 28 NMSA 1978 is 16 enacted to read: 17 "[NEW MATERIAL] EMPLOYMENT DISCRIMINATION--PROHIBITION.--18 19 Α. It is an unlawful discriminatory practice for an 20 employer to: refuse a request for reasonable (1)21 accommodation or fail to make reasonable accommodation for an 22 employee or job applicant with a need arising from pregnancy or 23 childbirth or a related condition, unless the employer 24 demonstrates that the accommodation constitutes an undue 25 .212185.1 - 3 -

2 (2) refuse to hire, discharge, refuse to 3 promote, demote or discriminate in matters of compensation or leave or terms, conditions or privileges of employment against 4 any person otherwise qualified for employment on the basis of a 5 need arising from that person's pregnancy or childbirth or a 6 7 related condition, including receipt of benefits under fringe 8 benefit programs, unless based on a bona fide occupational 9 qualification;

(3) print or circulate or cause to be printed or circulated any statement, advertisement or publication; use any form of application for employment; or make any inquiry regarding prospective employment that expresses, directly or indirectly, any limitation, specification or discrimination as to a need arising from a person's pregnancy or childbirth or a related condition, unless based on a bona fide occupational qualification; and

(4) require an employee to take paid or unpaid leave if another reasonable accommodation can be provided to the employee with a need arising from pregnancy or childbirth or a related condition.

B. It is an unlawful discriminatory practice for an employer to refuse to list, properly classify for employment or refer a person for employment in a known available job for which the person is otherwise qualified on the basis of a need .212185.1

arising from the person's pregnancy or childbirth or a related 2 condition, unless the employer's action is based on a bona fide occupational qualification. 3

C. It is an unlawful discriminatory practice for an employer's agent to comply with a request from an employer for referral of applicants for employment if the request indicates, 7 directly or indirectly, that the employer discriminates in employment on the basis of a need arising from the person's 8 pregnancy or childbirth or a related condition, unless that discrimination is based on a bona fide occupational 10 11 qualification.

D. An employer shall keep confidential an employee's request for an accommodation pursuant to the Pregnant Worker Accommodation Act, including the employee's need arising from pregnancy or childbirth or a related condition, and all accommodations granted pursuant to that act."

SECTION 4. A new section of Chapter 28 NMSA 1978 is enacted to read:

"[NEW MATERIAL] PREGNANCY ACCOMMODATION NOTICE .--

An employer shall provide written notice of an Α. employee's rights pursuant to the Pregnant Worker Accommodation Act to be free from discrimination related to pregnancy or childbirth or a related condition, including the right to reasonable accommodation for a need arising from pregnancy or .212185.1

childbirth or a related condition, to: 1 2 (1)job applicants; 3 (2) new employees at the commencement of employment; 4 existing employees within one hundred 5 (3) twenty days after the effective date of the Pregnant Worker 6 7 Accommodation Act; and (4) within ten days of an employee giving an 8 9 employer notice of pregnancy or childbirth or a related condition. 10 The notice provided pursuant to this section Β. 11 12 shall also be conspicuously posted at an employer's place of business in an area accessible to employees." 13 SECTION 5. A new section of Chapter 28 NMSA 1978 is 14 enacted to read: 15 "[NEW MATERIAL] RETALIATION PROHIBITED.--It is a violation 16 17 of the Pregnant Worker Accommodation Act for an employer or any 18 other person to refuse to hire, discharge, refuse to promote, 19 demote or discriminate against a person in matters of 20 compensation or leave or terms, conditions or privileges of employment in retaliation for the person having a need arising 21 from pregnancy, childbirth or a related condition, for 22 asserting a claim or right pursuant to the Pregnant Worker 23 Accommodation Act, for assisting another person to assert a 24 25 claim or right pursuant to the Pregnant Worker Accommodation .212185.1 - 6 -

A new section of Chapter 28 NMSA 1978 is 3 4 enacted to read: 5 "[NEW MATERIAL] GRIEVANCE PROCEDURE.--6 Α. A person claiming to be aggrieved by an unlawful 7 discriminatory practice in violation of the Pregnant Worker 8 Accommodation Act may seek relief under the Human Rights Act 9 pursuant to the process set out in Sections 28-1-10 through 28-1-13 NMSA 1978. 10 In addition to any judgment awarded to the 11 Β. 12 plaintiff of actual damages and reasonable attorney fees, a 13 court may order: 14 (1) in its discretion, treble damages; (2) appropriate injunctive relief, including 15 requiring an employer to post in the place of business a notice 16 describing violations by the employer, as determined by the 17 18 court or a copy of a cease and desist order applicable to the 19 employer; 20 (3) appropriate equitable relief, including employment reinstatement or promotion; or 21 in its discretion, punitive damages to an (4) 22 employee or job applicant." 23 SECTION 7.
