HOUSE EXECUTIVE MESSAGE NO. 86

Dear Speaker Egolf and Members of the House:

I am pleased to sign House Bill 349 and enact into law funding for significant infrastructure investments throughout New Mexico. Sound investment of public funds is essential for the State's economic growth, protection of New Mexico's natural resources, and the quality of life of New Mexico communities. This bill funds more than $\$ 422$ million in projects. A total of $\$ 132$ million in state agency capital projects are funded, including $\$ 10$ million for construction projects at Spaceport America, $\$ 9$ million for a new state police district office for the Department of Public Safety, almost $\$ 9$ million for school bus replacement, approximately $\$ 5$ million for public safety radio communications, and $\$ 5$ million for corrections facilities statewide. The bill also funds $\$ 19$ million for tribal projects, $\$ 84$ million for public safety projects, $\$ 82$ million for water and wastewater projects, $\$ 25$ million for higher education institutions, over $\$ 24$ million for public schools, $\$ 12$ million for road projects and over $\$ 10$ million for acequias and ditches.

While House Bill 349 does much to address our State's infrastructure needs, the bill includes several projects that lack proper planning or are not ready to proceed. Additionally, at this time of global economic uncertainty, it has become necessary and fiscally prudent to veto some projects that otherwise have merit, particularly those funded from general fund monies that would otherwise be available to bolster reserves. For these and other reasons, I have vetoed $\$ 100$ million in general fund projects, and $\$ 9.6$ million in severance tax bond projects. Together, these two categories of vetoes total approximately $20 \%$ of the total amount of capital outlay provided for in House Bill 349.

In some instances I have exercised the power accorded to me by Article IV, Section 22 of the New Mexico Constitution to disapprove "any part or parts" of House Bill 349. N.M. Const. Art. IV, § 22. I have done so to remove unduly or unnecessarily restrictive language on decisions well within the agencies' executive discretion, to ensure funds are appropriated to the correct fiscal agent, and to make certain that capital outlay monies are sufficient to fund corresponding public projects. I
have also vetoed appropriations where the recipients have not yet used their capital funds from the current fiscal year; there is no need to devote more of New Mexico's money into projects that are not moving forward.

As I mentioned last year in Senate Executive Message No. 48, the capital outlay process mainly exists to fund intelligent investments into critical infrastructure, and relatively small projects should not be addressed by capital outlay funds. State and local governments have other means well within their capacities to fund these smaller projects. Accordingly, with the exception of school safety projects, an area in which we must make whatever impact we can, I have vetoed capital outlay appropriations under $\$ 10,000$. In some instances, other funding sources are available for vetoed projects. If those funds are insufficient for the vetoed projects and the need is dire, I encourage the legislative sponsors to contact me.

Finally, I have made the difficult decision to veto a number of projects that have merit, but must be vetoed in the interest of fiscal responsibility. In the days since the end of the legislative session, we have received unfortunate news about the steep drop in oil prices due to the global COVID-19 outbreak and a crude oil price war between Saudi Arabia and Russia. I fully support efforts to improve the state's infrastructure, but current economic conditions require me to veto several projects. I am optimistic that these projects can be responsibly funded in a future capital outlay bill.

The projects vetoed for these fiscal reasons were funded through the general fund, beginning in Section 49 of the bill. Capital outlay is typically funded through severance tax bonds, and general fund projects are less common in a capital outlay bill absent very strong economic conditions. Accordingly, vetoing these general fund projects preserves the spirit of capital outlay while ensuring that the state's reserves remain adequately funded. I would note that vetoes of general fund projects directly bolster state reserves, whereas vetoes of severance tax bond projects do not. In vetoing most of the general fund capital outlay projects, I have carved out and chosen not to veto those general fund projects that address critical public safety and public health needs. Consistent with the distinction drawn between general fund projects and severance tax bond projects, I have applied a broader and more traditional approach to vetoes of severance tax bond projects, as described herein.

New Mexico individuals and families deserve that we do our best to allocate capital resources to projects that meet the needs of local communities and prioritize our most significant needs and common goals. Viewed as a whole, this legislation furthers those ends.

Accordingly, I this day SIGN and RETURN:
