WHEREAS, combining their shared knowledge and expertise, CHRISTUS St. Vincent regional medical center nurses and physicians have developed evidence-based protocols for slashing infection rates, improving the safety of medication administration, reducing length of stay for babies born with neonatal abstinence syndrome and much more; and

WHEREAS, as part of CHRISTUS St. Vincent regional medical center's "journey to always", associates and

clinicians work to improve the patient experience at every point of contact, with a promise to each patient that the patient will always be treated with the utmost dignity and respect and that the patient's needs and expectations will always be addressed to the best of the hospital's ability; and
