### SUMMARY

#### Synopsis of HSEIC

The House State Government, Elections and Indian Affairs Committee (HSEIC) amendment to House Bill 211 changes the original reversion date from FY21 to FY22.

#### Synopsis of Bill

House Bill 211 appropriates \$50 thousand from the general fund to the Indian Affairs Department (IAD) to provide security services to ensure public safety at an international Native American cultural event in Santa Fe.

There is no effective date of this bill. It is assumed that the effective date is 90 days following adjournment of the Legislature.

### FISCAL IMPLICATIONS

The appropriation of \$50 thousand contained in this bill is a nonrecurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of FY21 shall revert to the general fund. The funds are to be used to provide security services at an international Native American cultural event in Santa Fe. The HSEIC amendment to the bill changes the original reversion date from FY21 to FY22.

**SIGNIFICANT ISSUES**

The event referenced in the bill is somewhat unclear. In its analysis, the Indian Affairs Department explains the event is most likely the Southwestern Association for Indian Arts Santa Fe Indian Market.

The New Mexico True website as a “one-of-a-kind event (that) provides a unique opportunity to buy directly from Native American artists from across North America. The Santa Fe Indian Market has long been the place where Native American art meets the world. Nearly 1,200 artists will be presenting their newest and best work for sale and admiration. The outdoor market provides a unique place to meet and buy directly from the nation’s top Native American artists, including youth, who represent nearly 100 tribes.”
