RELATING TO CAPITAL EXPENDITURES; REQUIRING PUBLICATION OF
ALLOCATIONS BY LEGISLATORS AND THE GOVERNOR OF CAPITAL OUTLAY
APPROPRIATIONS OR BOND AUTHORIZATIONS Hf11→; DECLARING AN
EMERGENCY←Hf11 .

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new section of Chapter 2, Article 3 NMSA 1978 is enacted to read:
